As a result of the primary development in the Wolfcamp and Bone Spring formations, the development of the Leonard has been delayed.

Otherwise, the simultaneous development and production of all formations would exceed infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water. Additionally, recent well results suggest that optimal development of this formation to recover the most minerals and reduce waste will require supplemental permits.
