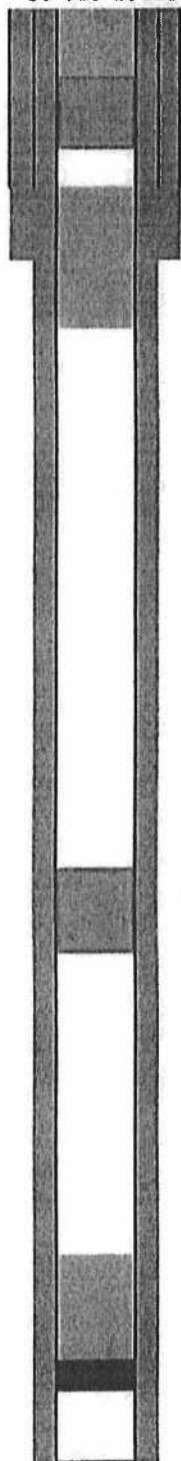

12/21/2022 Made gauge ring run to 2700'. Set 5.5" CIBP on wireline at 2670'. RIH with tubing and tagged CIBP. Circulated MLF and tested casing to 500#. Casing good. Spot 25 sx Class C cement on top of CIBP. POOH to 1764' and spot 25 sx cement. POOH and SION.

12/22/2022 Tagged cement at 1523'. POOH to 723' and circulated cement to surface with 75 sx. Rigged down, dug out cellar, and removed the wellhead. Filled up both strings with 10 sx cement. Installed below ground marker, cleaned the pit and removed the anchors.
