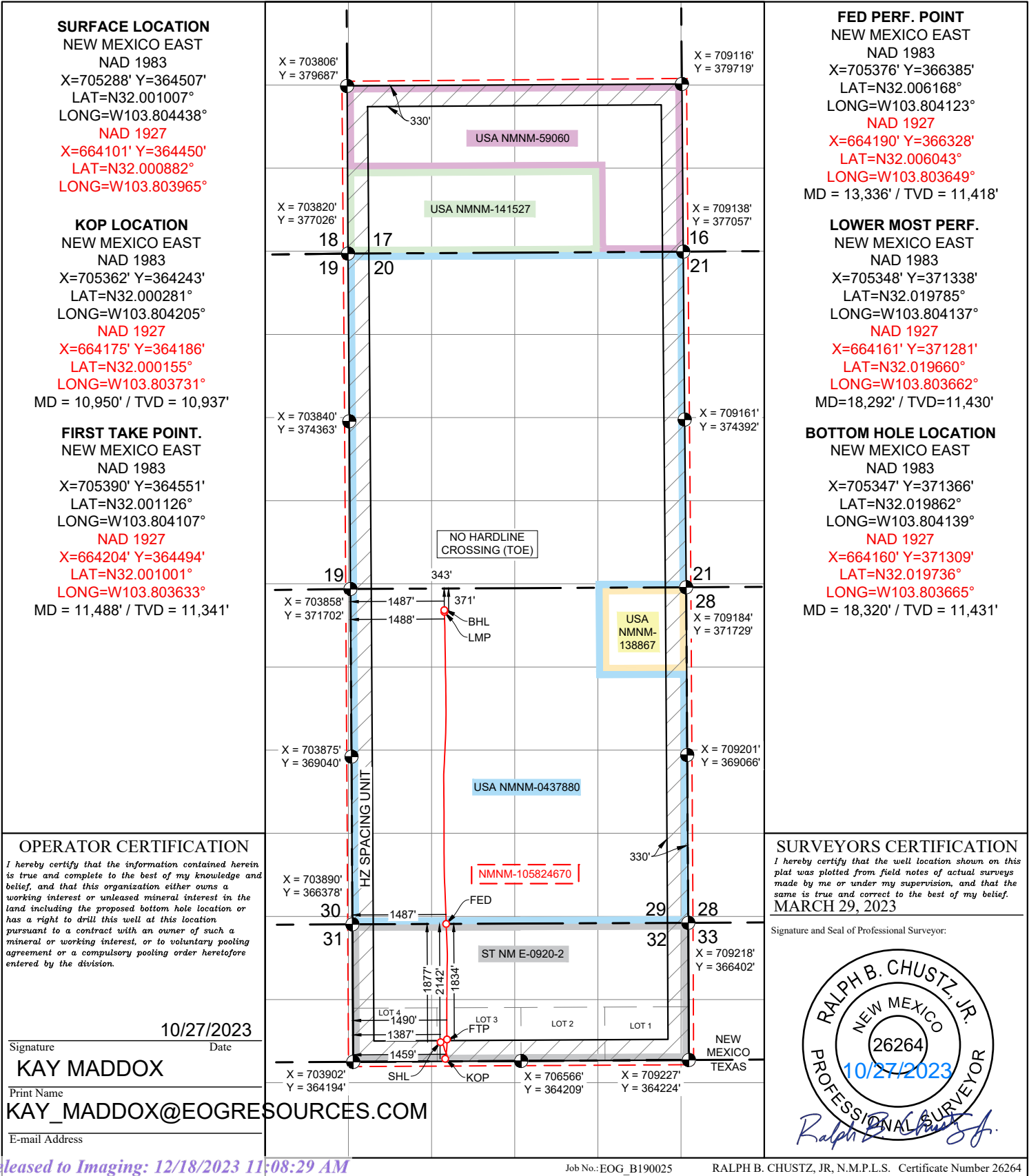

WELL LOCATION AND ACREAGE DEDICATION PLAT

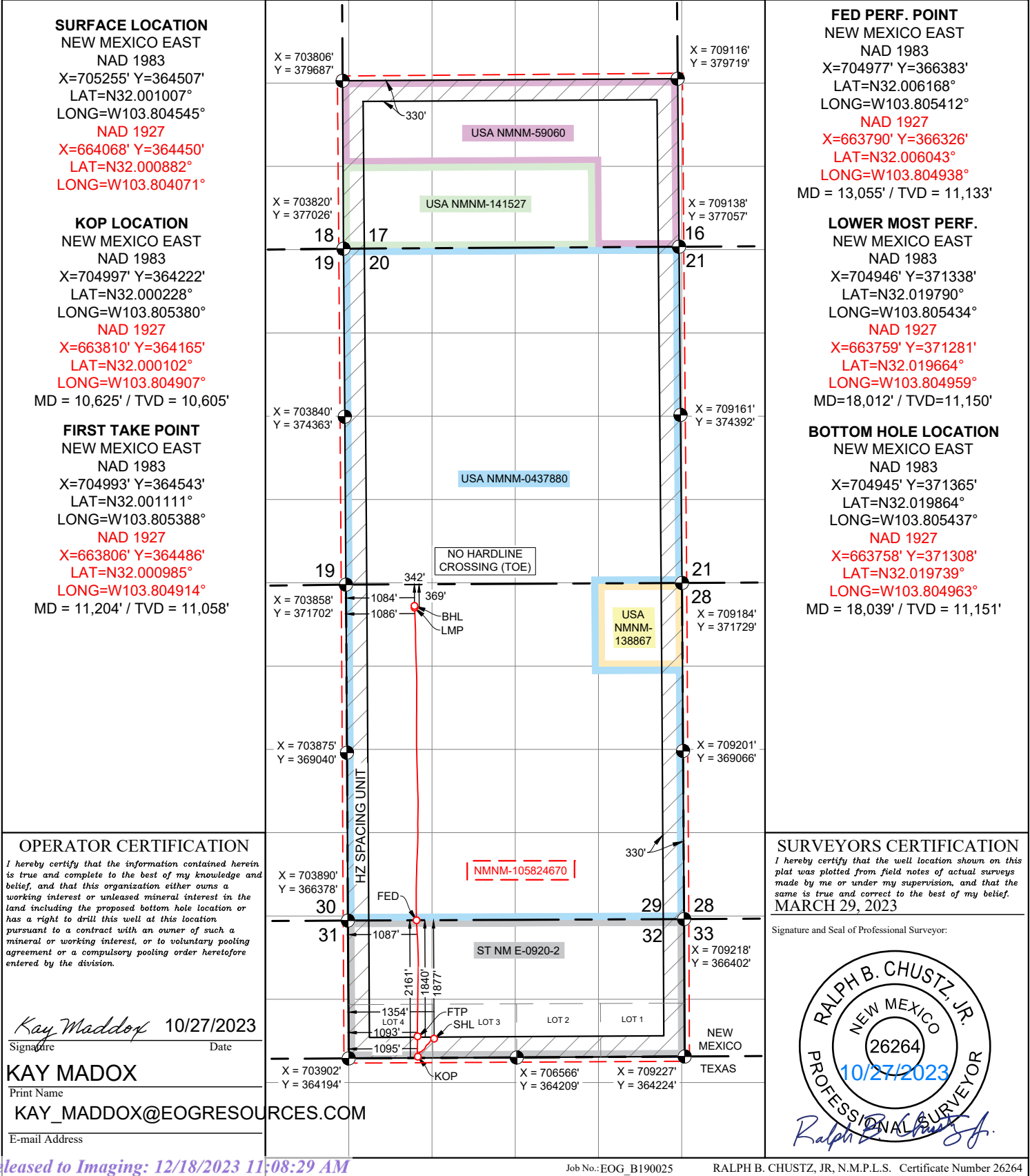
