Actual Procedure: Well spud on 9/20/2022 at 20:45 9/20/2022: Drill 17.5 inch surface hole to 550, 9/21/2022: Run 13.375 inch 54.5 lb J55 surface casing to 541 ft. Pump 20 bbls water spacer, followed by 495 sks of 14.8 ppg tail cmt. Drop plug and displace with 73 bbls brine. 50 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 9/21/2022: Test BOPS. Drill 12.25 intermediate hole to 2010 ft. 9/24/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 1999 ft. Pump 20 bbls fresh water spacer, followed by 370 sks of 12.8 ppg lead cmt, 210 sks of 14.8 ppg tail cmt. Drop plug and displace with 148 bbls of fresh water. 48 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test. 10/3/2022: Drill 8.75 inch production hole to 7172 then switch to 7.875 inch to 17695 ft. 10/10/2022: Run 5.5 inch 20 lb P-110 production casing to 17676 ft MD. Pump 40 bbls fresh water, then 425 sks of 10.5 ppg lead and 1685 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 391 bbls fresh water. 55 bbls cement returned to surface. Est TOC at 0 ft.
