3/5/2023: Test BOPS. Drill 12.25 intermediate hole to 2002 ft.

3/6/2023: Run 9.625 inch 40 lb J-55 intermediate casing to 1988 ft. Pump 40 bbls water spacer, followed by 380 sks of 12.8 ppg lead cmt, 210 sks of 14.8 ppg tail cmt. Drop plug and displace with 147 bbls fresh water. 42 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

3/6/2023: Drill 8.75 inch production hole to 6628 ft then switch to 7.875 in hole to 17554 ft.

3/15/2023: Run 5.5 inch 20 lb P-110 production casing to 17538 ft MD. Pump 40 bbls fresh water spacer, then 390 sks of 10.5 ppg lead cmt and 1720 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water, 368 bbls fresh water. 22 bbls returned to surface. Est TOC at 0 ft.
