Mr. Bishop,

Please note that despite the Division's approval for Mewbourne's proposed well, 30-015-54577 LAYLA 26 35 FEE #523H, not detailing the conditions of approval; Mewbourne is stipulated to follow the standard APD conditions as depicted below in this email chain.

Conditions
Notify OCD 24 hours prior to casing & cement <small>Added on 12/29/2023 by dmccclure</small>
Will require a File As Drilled C-102 and a Directional Survey with the C-104 <small>Added on 12/29/2023 by dmccclure</small>
Once the well is spud, to prevent ground water contamination through whole or partial conduits from the surface, the operator shall drill without interruption through the fresh water zone or zones and shall immediately set in cement the water protection string <small>Added on 12/29/2023 by dmccclure</small>
Cement is required to circulate on both surface and intermediate1 strings of casing <small>Added on 12/29/2023 by dmccclure</small>
Oil base muds are not to be used until fresh water zones are cased and cemented providing isolation from the oil or diesel. This includes synthetic oils. Oil based mud, drilling fluids and solids must be contained in a steel closed loop system <small>Added on 12/29/2023 by dmccclure</small>
The Operator is to notify NMOCD by sundry (Form C-103) within ten (10) days of the well being spud <small>Added on 12/29/2023 by dmccclure</small>
If cement does not circulate on any string, a CBL is required for that string of casing <small>Added on 12/29/2023 by dmccclure</small>
