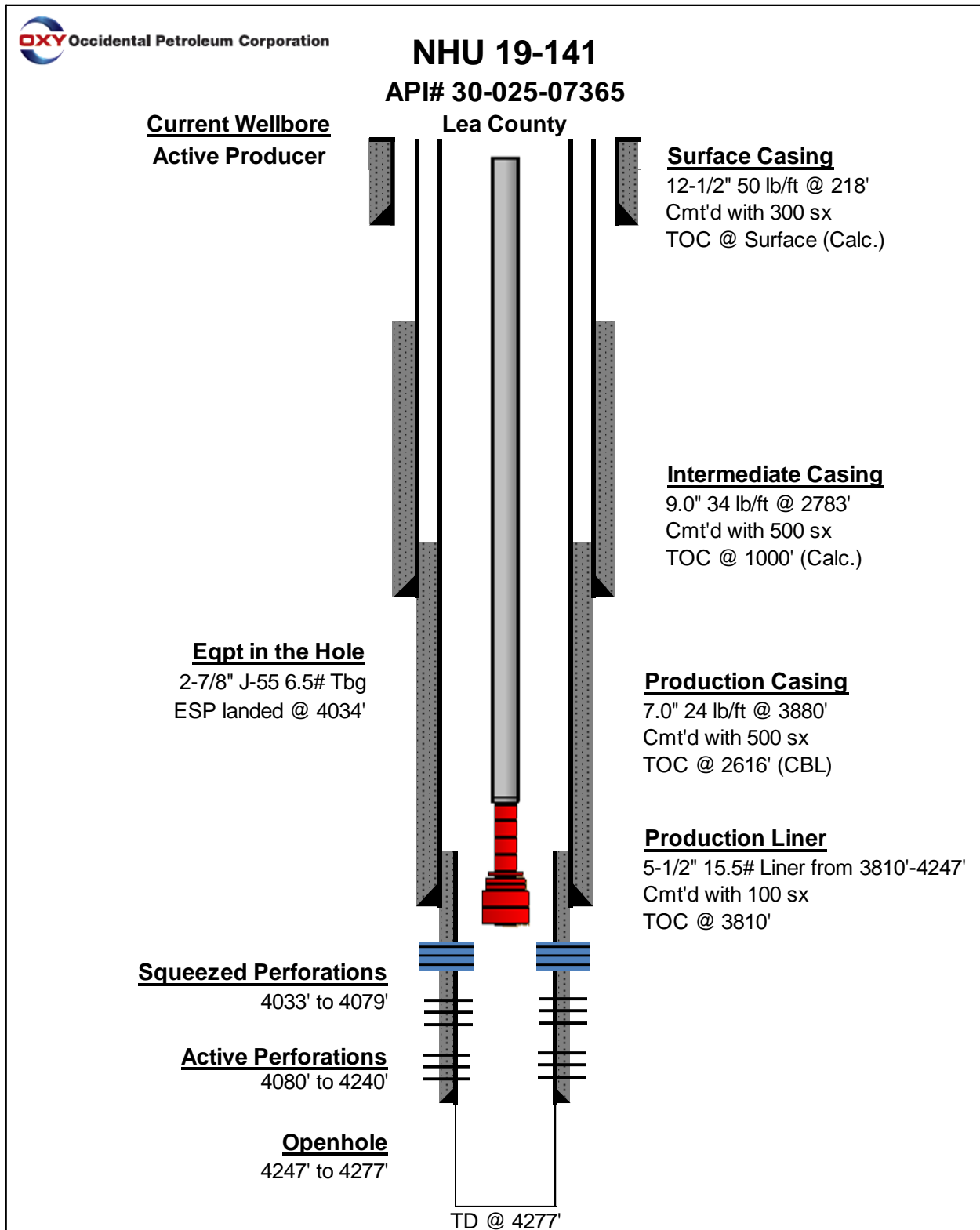

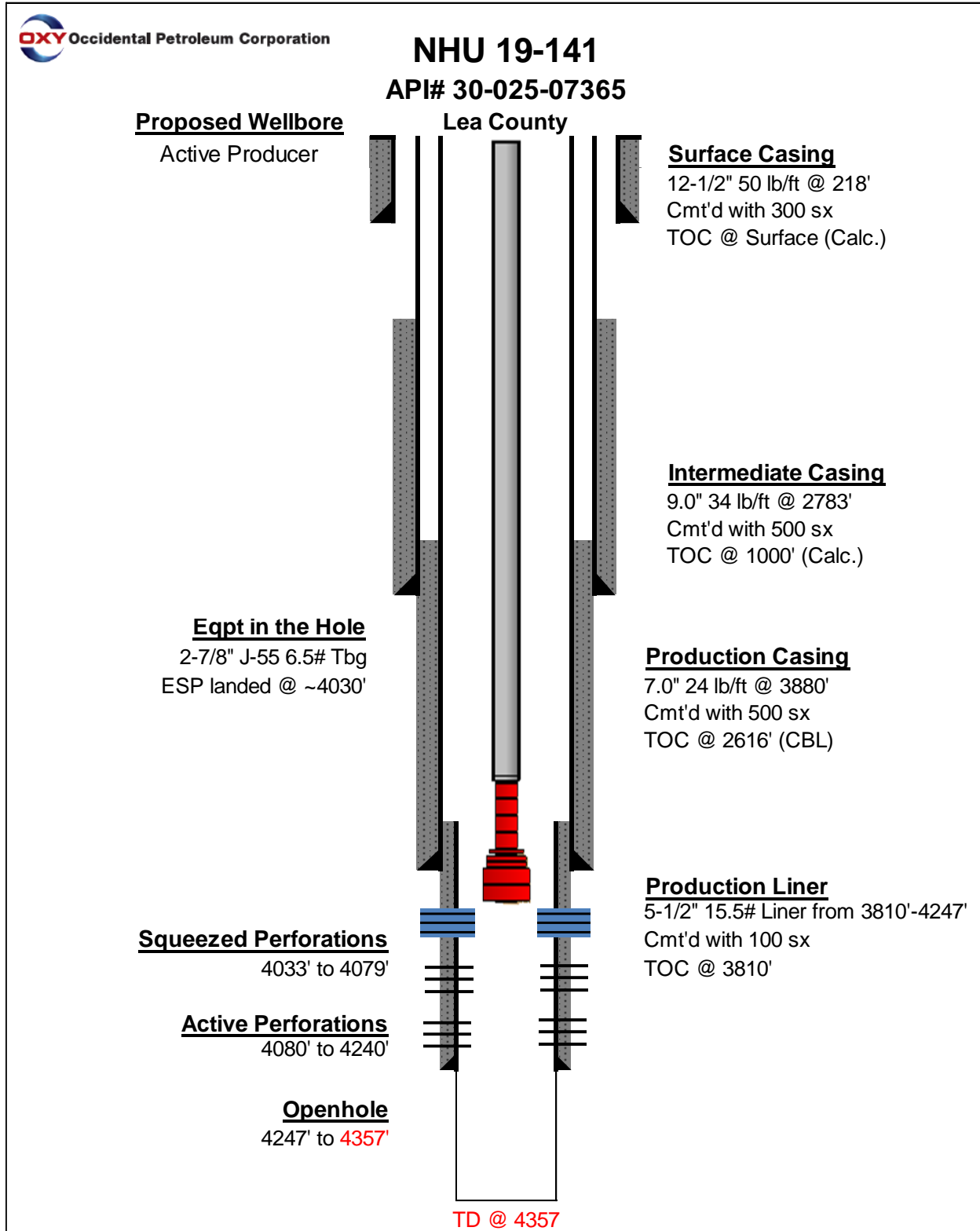

- 5) Deepen well 80' to new TD of 4357' x POOH w/ bit
- 6) RIH w/ 5-1/2 treating packer & ~175' of tailpipe. Set packer @ ~4152'.
- 7) Acid stimulate openhole with ~7000 gal 15% HCL
- 8) POOH w/ packer
- 9) RIH w/ production eqpt landing bottom of ESP at ~4030'.
- 10) RD PU
- 11) Return well to production
