Pulled tubing. ND WH. NU BOP. Cut tubing 2 1/2 jts above SN at 8608'. TOH with tubing. LD cut jt. Blow pressure off. TOH with kill string. TOH with tubing and LD fishing equip. TIH with 10 stands. Pulled pump. TIH with 2 7/8 slotted collar, check valve. Tag sand at 8750'. TOH with tubing. TIH with production equipment. 5 psi on well. Blow well down. ND BOP, NU WH. Swabbing from SN 8568'. ND swab equipment. TIH with rods and pump. Spaced rods out. Pressured tubing to 500 psi, held good. Rigged down well servicing equipment and cleaned location.
