Pump 30 sxs Class C cement from 1,425' – 983'. WOC for 4 hours. RIH & tag TOC plug at 977'. Circ well with 20 bbls MLF. Perf @ 625'. Pump 167 sxs Class C cement from 625' to surface inside/out 4-1/2" production csg & 8-5/8" surface csg. Let cement sit overnight. 11/16/23: Verify cement at surface. RDMO P&A rig. 11/20/23: Dig out and cut off WH 3' below GL, weld on steel plate to casing and install 4" OD x 4' tall above ground dry hole marker.
