Displace cement. Circulated 140 bbls cement to surface. Pressure test casing to 1500 psi for 30 min. Good test. Nipple up and test BOP 250/5000 psi. Held each test for 10 min. Good test. (03/14/2022) TD 12-1/4" hole at 3703'. RIH 10-3/4" 45.5# J55 BTC csg set at 3688'. Cement lead 705 sx yield 1.68 cu ft/sk. Tail w/130 sx yield 1.74 cu ft/sk. Displace cement.
