Procedure Description: EPIC Energy acquired this well from West Largo Corporation in 2023 and with the approval of the Change of Operator, this well was put on EPIC’s “inactive” list by the NMOCD. Historically, the well was economical but was shut down by West Largo Corp for reasons unknown to EPIC. EPIC Energy is requesting approval to isolate the perforated interval (2228’-2418’) via 2-3/8” tubing and a 4-1/2” casing packer to perform a swab/production test to see if the well is still productive. Estimate 2-3 days to change out tubing, clean out well (if necessary), run packer and swab. If productive, EPIC is seeking approval to leave packer in place for up to 90 days to monitor production before doing any further investigation on the wellbore.
