Rigged up well servicing equipment. Flushed tubing with 70 bbl water and 20 gal solvent. Pressure tested good. Pulled rods. RU BOP. Unset TAC. POOH with tubing and tally. Cont'd POOH. TIH with Venturi and tubing. Began drilling with 4.8" bit and Venturi. POOH with tubing and BHA. TIH with 3-1/2" notch collar and Venturi assembly. Cont'd cleanout. RD swivel. POOH with tubing and BHA. RIH with production tubing. Spaced well out and hang on well. Load with 22 bbls KCL water and tested to 500 psi, held good. Rigged down and cleaned location. Returned well to production.
