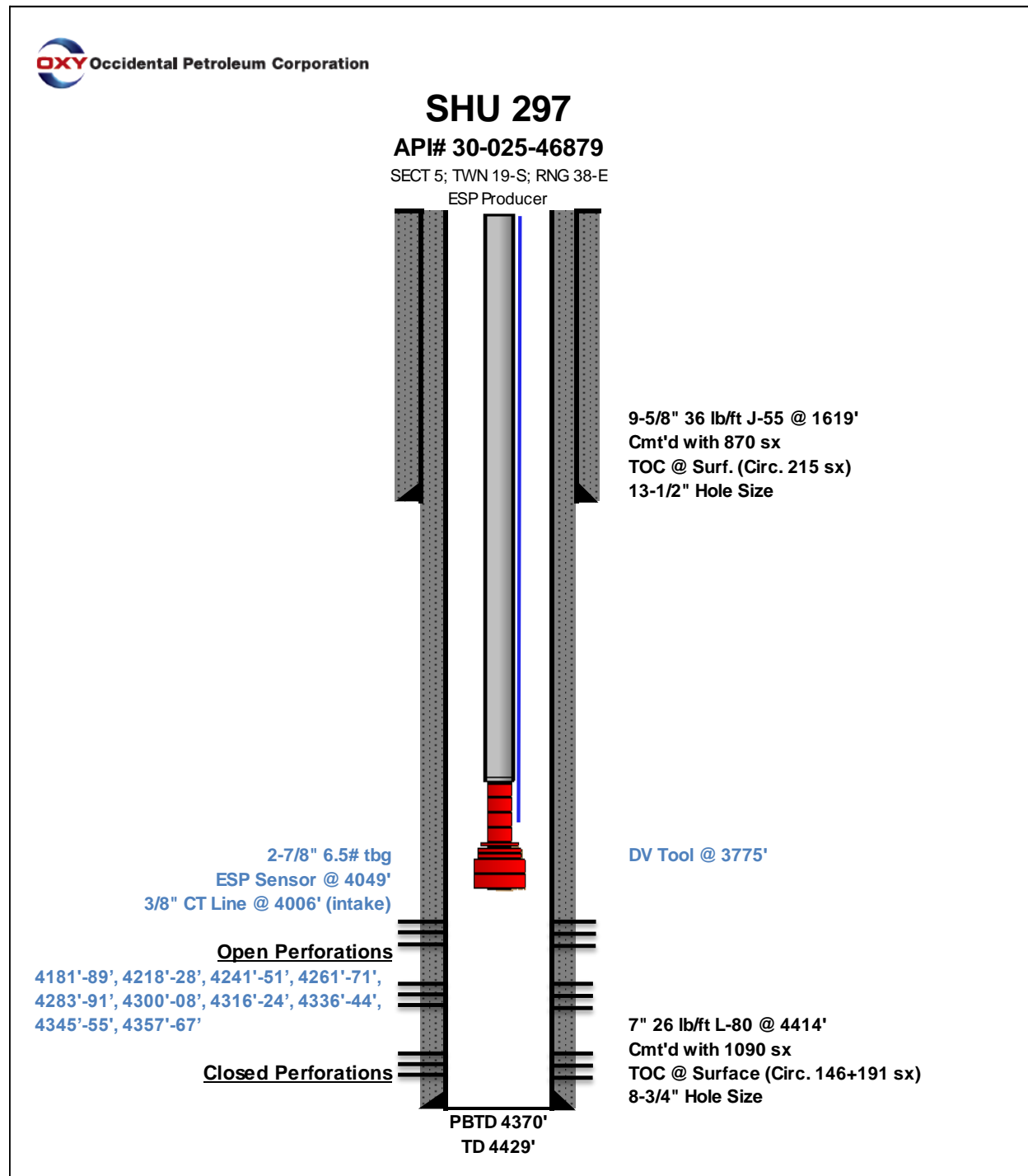

Proposed WBD



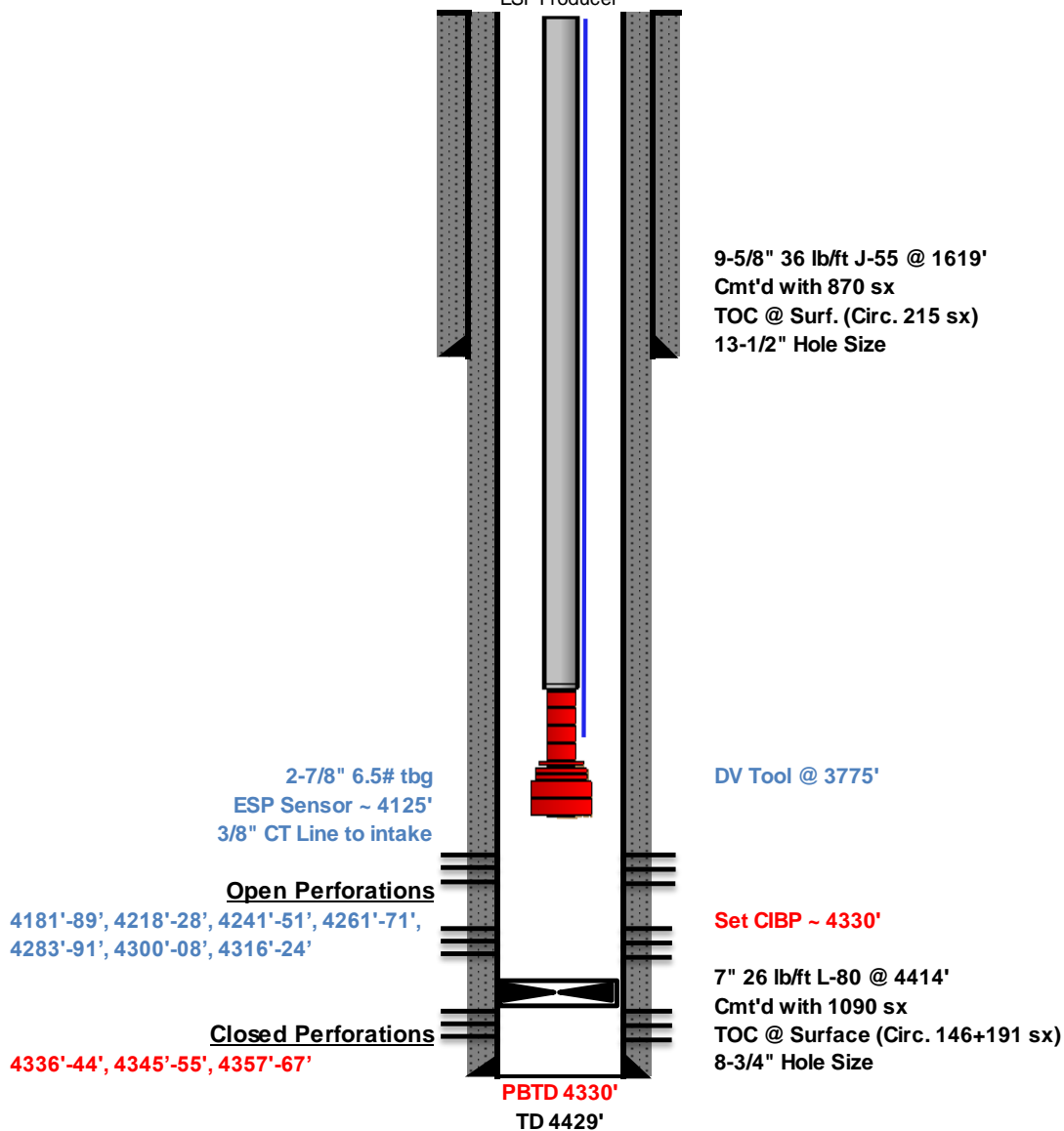
