

12/14/23 - SICP=20PSI, NO BH, BWD. MIRU WL. JHA with Crew. Run In with 2.375 GR and Junk basket, hittling on collars going in well. POH and change out GR to 2.25"od. Git down to 525'. POH with Junk basket. Had black silt in baskit. Flush wellbore with 3 bbls of water. TIH with CIBP, Set at 506' (csg collar at 510'). POH with setting tool. Trickled water in casing. RUN with CBL tools. Found possible hole at 340' to 342', Laid down tools and attempt to pressure test casing. Got to 450 psi and pressure dropped 100 psi. No test. Ru to dump bail cement with 3 runs (54'). TOC at 456', Attempt to pressure test to 500 psi. SD lost 250 psi in 60 seconds. RIH with wireline and shot 4 holes at 150 ft. Verified all shots went. RU kill truck and attempt rate and circulation. Pumped in at 200 psi, 1.5 bpm. Pumped a total of 2 bbls and establish circulation. RDMOL to Pet Inc #5.

2/13/24 - SICP=10PSI. MIRU. JHA with crew. RU to 2-7/8 casing valve. Established injection rate of 2 bpm @ 200 psi. Got circulation back, pumped 3 bbls water. M&P 50 sks, 1.15, 57.5 cuft, 10.2 bbls, 15.8# class "G" neat cement. Started bridging as soon cementer started pumping cement. Pressure broke back and started getting circulation. 350 psi at 1.5 bpm. Circulated approximately 4 bbls of good cement. Washed pump and lines and secured equipment for the evening. Will be cutting off in the morning. NNMinerals inspector Natasha Dishface on location to witness the operation.

2/14/24 - SICP=OPSI, JHA with crew, Backhoe dug out cellar deeper (Cattle trampling around well) Cut casing strings off. Cement at surface on both strings. Welded dry hole marker onto casing strings, Backhoe covered up the marker and backfilled cellar as per NNMinerals Inspector. (Cattle on circle). Moved to PET Inc #5. Off location at 09:30. NNMinerals Inspector Natasha Dishface on location to witness the operation.
