

Hilcorp is planning to move onto the NAVAJO 21 2 (API # 3004531776) tomorrow (3/21/2024) for P&A.

Attached is the CBL run 7/15/2005. The log shows TOC @ ~78'. It appears this is the depth where they stopped logging at the time, and therefore the TOC may be shallower. Surface casing shoe is at ~235'.

Moving forward, Hilcorp requests to move forward with the approved NOI, however using Class G cement instead of the NOI approved Class III cement. Hilcorp will top off as needed.
