Procedure Description: Enduring Resources IV, LLC (Enduring) is requesting permission from the BLM to convert an existing facility containing a water supply well located on BLM-owned surface, WLU 2309-24N (NMOSE well SJ-4301 POD3), to an injection well for recovered fracturing water from production well completions. The existing well is completed in the Entrada Formation, with water currently extracted for use in production well completions. The Entrada formation contains low quality water and the formation is commonly used for both extraction and injection purposes in the San Juan Basin. The proposed injected water would be of similar quality to the existing water present in the Entrada Formation. Currently, the New Mexico Oil Conservation Division (NMOCD) has jurisdiction for permitting salt-water disposal wells (Class II Injection wells) and requires that surface owners grant permission for such use.
