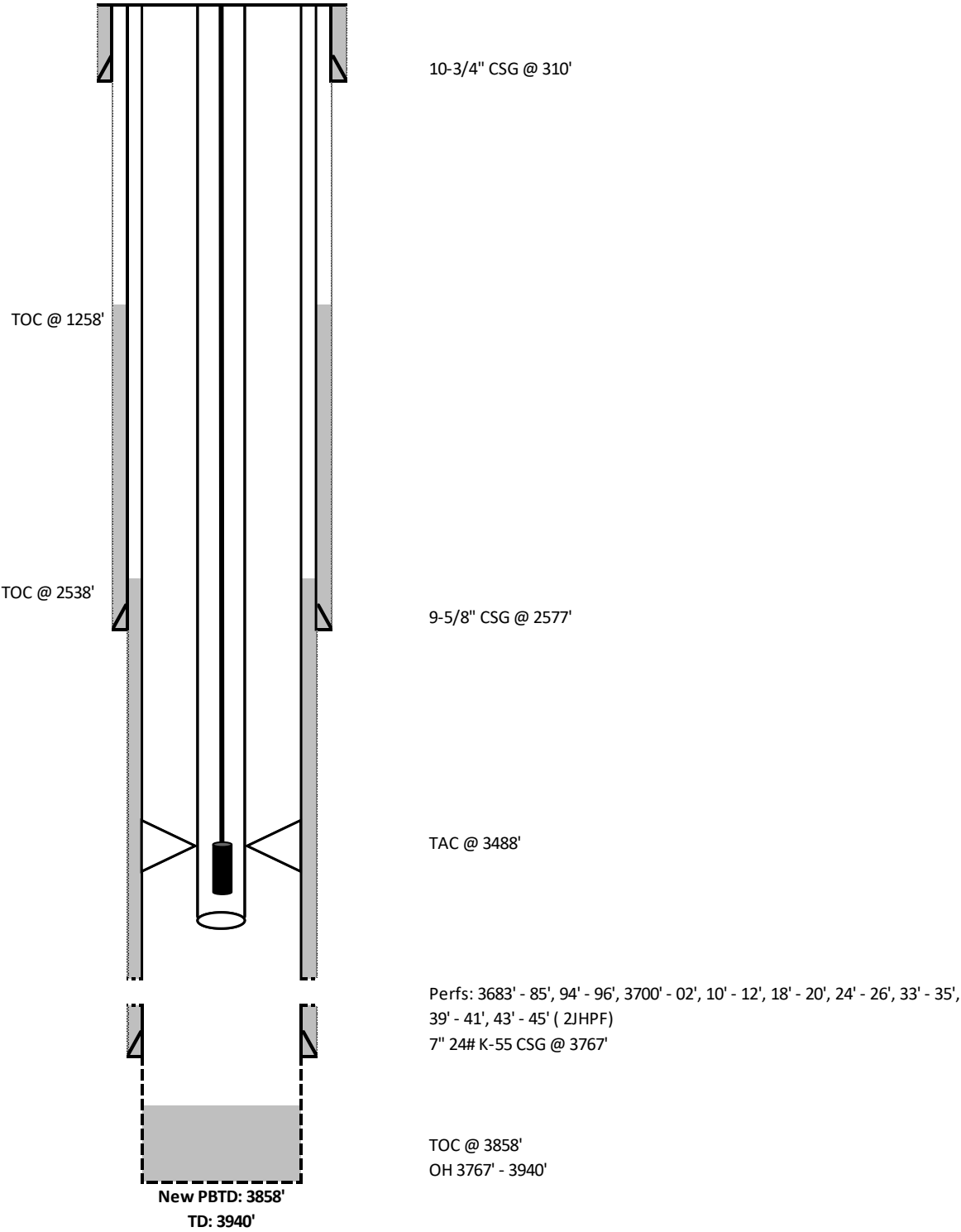

1. MIRU WO Rig on 6/12/2024.
2. ND drive head.
3. Pull rotor out of the stator and POOH with rods. Found body break.
4. ND WH, and NU BOP.
5. Released TAC and scanned tubing OOH.
6. Tagged PBTD @ 3901' and dump bailed cement from 3901' – 3875'.
7. Dumped benzo acid rocks on top of the cement.
8. Set treating packer @ 3665'.
9. Acidize below packer with 6000 gallons and used rock salt for diversion. WOA.
10. Circulated hole clean.
11. Tag new PBTD @ 3858' and POOH.
12. RIH with TAC and tubing. Set TAC @ 3488'.
13. RIH with the ALS.
14. Notified NMOCD.
15. RDMO on 6/20/2024.
16. RTP.
