Procedure Description: BLM Bond NMB001079 Surety Bond No.: RLB0015172 After intermediate 1 casing was set and cemented in place, we proceeded to perform a casing integrity test above the DV Tool / Packer assembly, this test was successful. However, upon drilling out our DV Tool / Packer Assembly we were unable to achieve a 1,500 psi casing test that would pass the 10% drop within 30 minutes. We were able to troubleshoot the pressure test and isolated the issue to our DV Tool / Packer assembly. We proceeded to test our casing via a test packer and were able to achieve a successful 1,500 psi test above and below the DV Tool / Packer assembly for 30 minutes confirming integrity of the casing string. As a remedial action we would like to drill ahead our intermediate 2 interval, which will case and cement to surface, further isolating the DV Tool / Packer assembly in question.

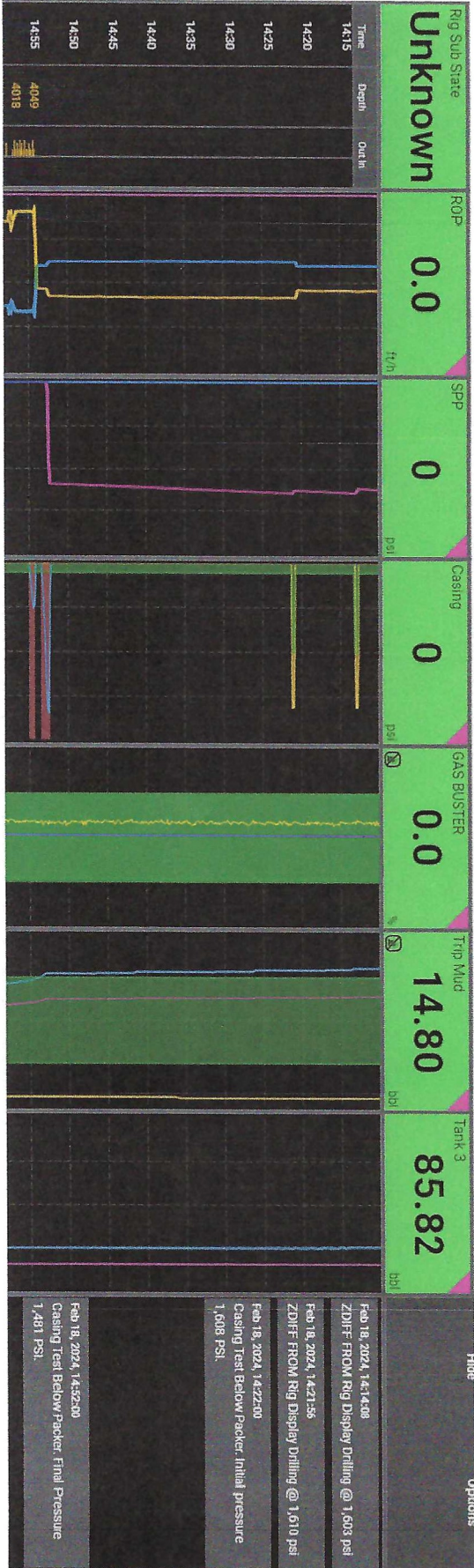
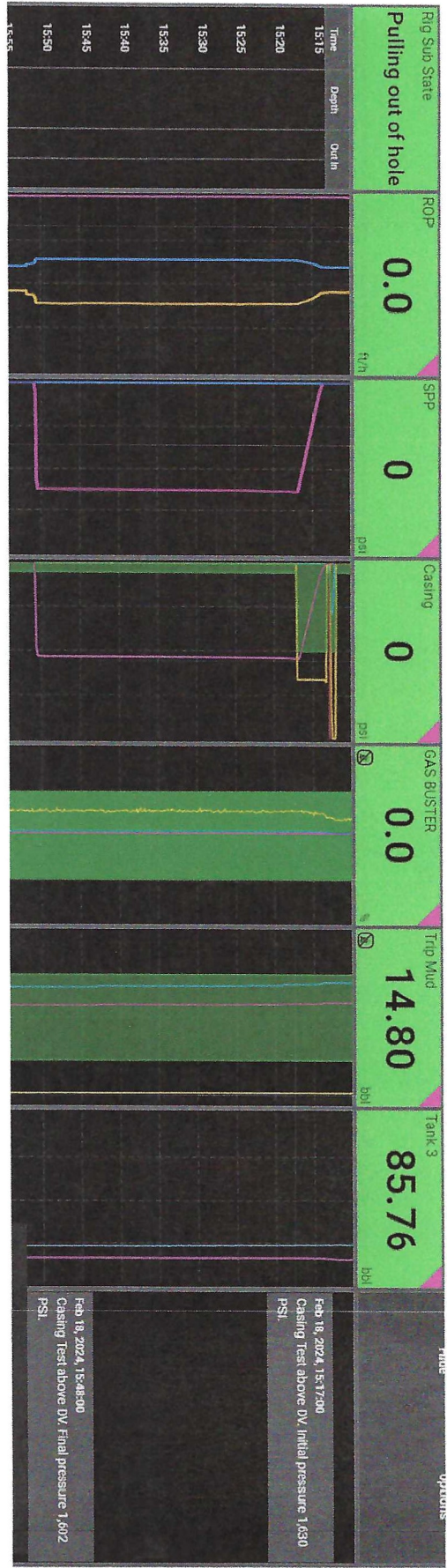
