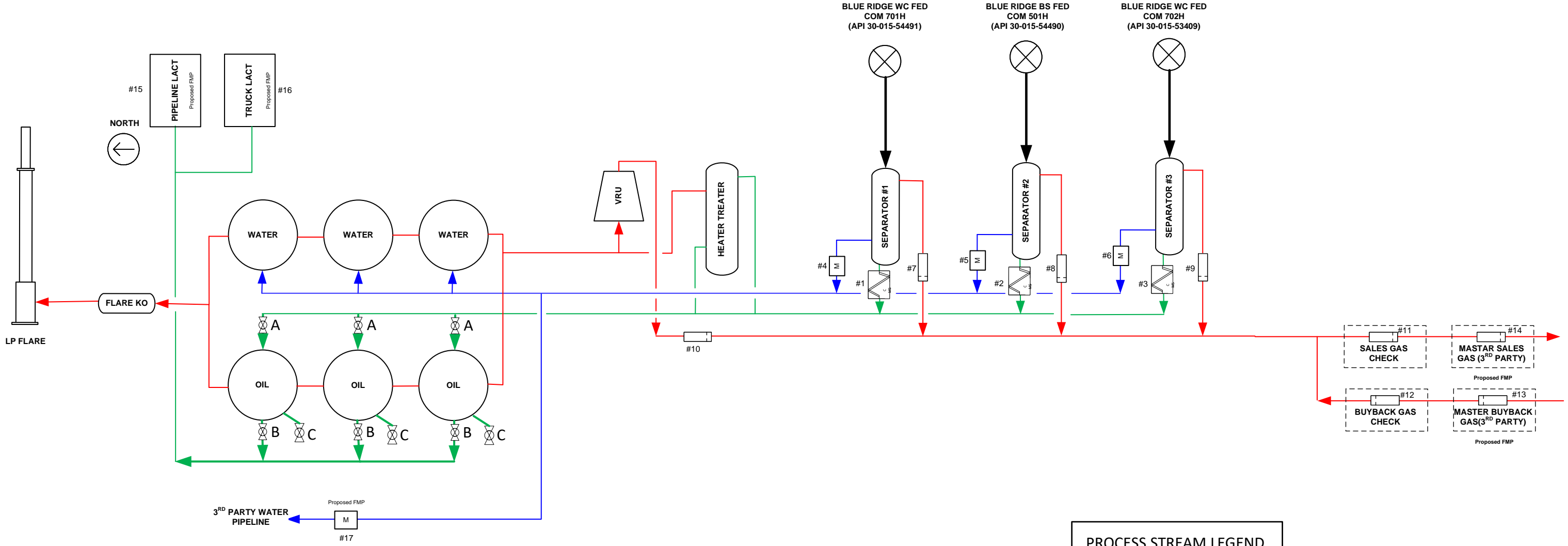

THE FOLLOWING GAS, OIL, AND WATER PROCESS DESCRIPTIONS OUTLINE PROCESS FLOW AND MEASUREMENT ON THIS PARTICULAR MULTI-WELL FACILITY DESIGN.

GAS: GAS PRODUCTION FROM EACH WELL WILL BE INPEDEPENDENTLY MEASURED AT ITS WELL-ALLOCATION GAS MEASUREMENT POINT WITHIN THE FACILITY GAS HEADER. THE GAS STREAM WILL THEN PASS THROUGH THE PREVIOUSLY DEFINED "GAS CDP FMP" WHERE IT WILL BE CUSTODY TRANSFERRED. THE RESULTING COMMINGLED CUSTODY TRANSFERRED GAS VOLUMES WILL THEN BE ALLOCATED BACK TO EACH PRODUCING WELL BASED ON FLOW MEASURED AT EACH WELL-ALLOCATION MEASUREMENT POINT PREVIOUSLY MENTIONED.

OIL: OIL PRODUCTION FROM EACH WELL WILL BE INDEPENDENTLY MEASURED AT ITS DEFINED "OIL FMP" WITHIN THE FACILITY OIL HEADER WHERE THE OIL WILL THEN BE ROUTED TO ITS DESIGNATED CUSTODY TRANSFER POINT. OIL VOLUMES MEASURED AT EACH WELL-SPECIFIC "OIL FMP" WILL BE ALLOCATED BACK TO THAT SPECIFIC WELL.

WATER: WATER PRODUCTION FROM EACH WELL WILL BE INPEDEPENDENTLY MEASURED AT ITS WELL-ALLOCATION WATER MEASUREMENT POINT PRIOR TO BEING COMMINGLED WITH ADDITIONAL WATER STREAMS FROM ADDITIONAL WELLS WITHIN THE FACILITY WATER HEADER WHERE THE COMMINGLED WATER WILL THEN BE ROUTED TO ITS DESIGNATED CUSTODY TRANSFER POINT. THE RESULTING COMMINGLED CUSTODY TRANSFERRED WATER VOLUMES WILL THEN BE ALLOCATED BACK TO EACH PRODUCING WELL BASED ON FLOW MEASURED AT EACH WELL-ALLOCATION MEASUREMENT POINT PREVIOUSLY MENTIONED.
