Actual Procedure: AMENDED Intermediate Casing & Cement showing outcome of CBLs and verbal authorization from BLM/NMOCD to proceed with completion ops. 7/9/24: NU BOPE. Full Function PT L250 H3000. PT pre-set 9.625" 36# J55 LTC casing 1500 (30min) all tests good & recorded on chart. Drill 8.75" hole from 387' to 5645' TD. 7/12/24: RIH with 159 jts of 7" 26# J55 LTC casing set from Surface to 5635' MD. RU to cement. 4k test on lines, test good. LEAD: Type III, 195 bbls (513 sx) 12.5 ppg, 2.15 yield, 12.06 gps. Surface to 4019'. TAIL: Type III, 47 bbls (159sx), 13.5 ppg, 1.71 yield, 8.88 gps. 4019' to 5635'. Drop and bump plug, 1250 FCP, pressure up to 1800. Check floats, floats held. Circulate. No loss of cement but only spacer was noted in returns to surface. 7/13/24: Run CBL. Liquid present in annulus. Some indications of crystallization (cement presence). Permission received from BLM, Virgil Lucero and NMOCD, Monica Kuehling to finish the drilling portion of the well with the understanding that an additional CBL would be needed and that prior authorization from both agencies would be required before any completion work 8/26/24: Run 2nd CBL. Shows cement set in annulus of the 7" casing up and into surface casing. 8/28/24: Verbal authorization received from BLM, Virgil Lucero and NMOCD, Monica Kuehling to proceed with completion work without the need for any 7" casing/cement remedial work. 9/5/24: CBLs uploaded to NMOCD successfully.
