<ol style="list-style-type: none"><li>1. Contact NMOCD and BLM (where applicable) 24 hours prior to MIRU.</li><li>2. Hold pre-job safety meeting. Verify cathodic is off. Comply with all NMOCD, BLM, and HEC safety and environmental regulations.</li><li>3. MIRU service rig and associated equipment; NU and test BOP.</li><li>4. Set a 4-1/2" CIBP or CICR at +/- 6,330' to isolate the Dakota Formation.</li><li>5. Load the well as needed. Perform a charted &amp; witnessed MIT by pressure testing the casing above the plug to 560 psig.</li><li>6. RU Wireline. Run CBL. Record Top of Cement.</li><li>7. RDMO service rig.</li></ol>

**NEWSOM B 9E - CURRENT WELLBORE SCHEMATIC**



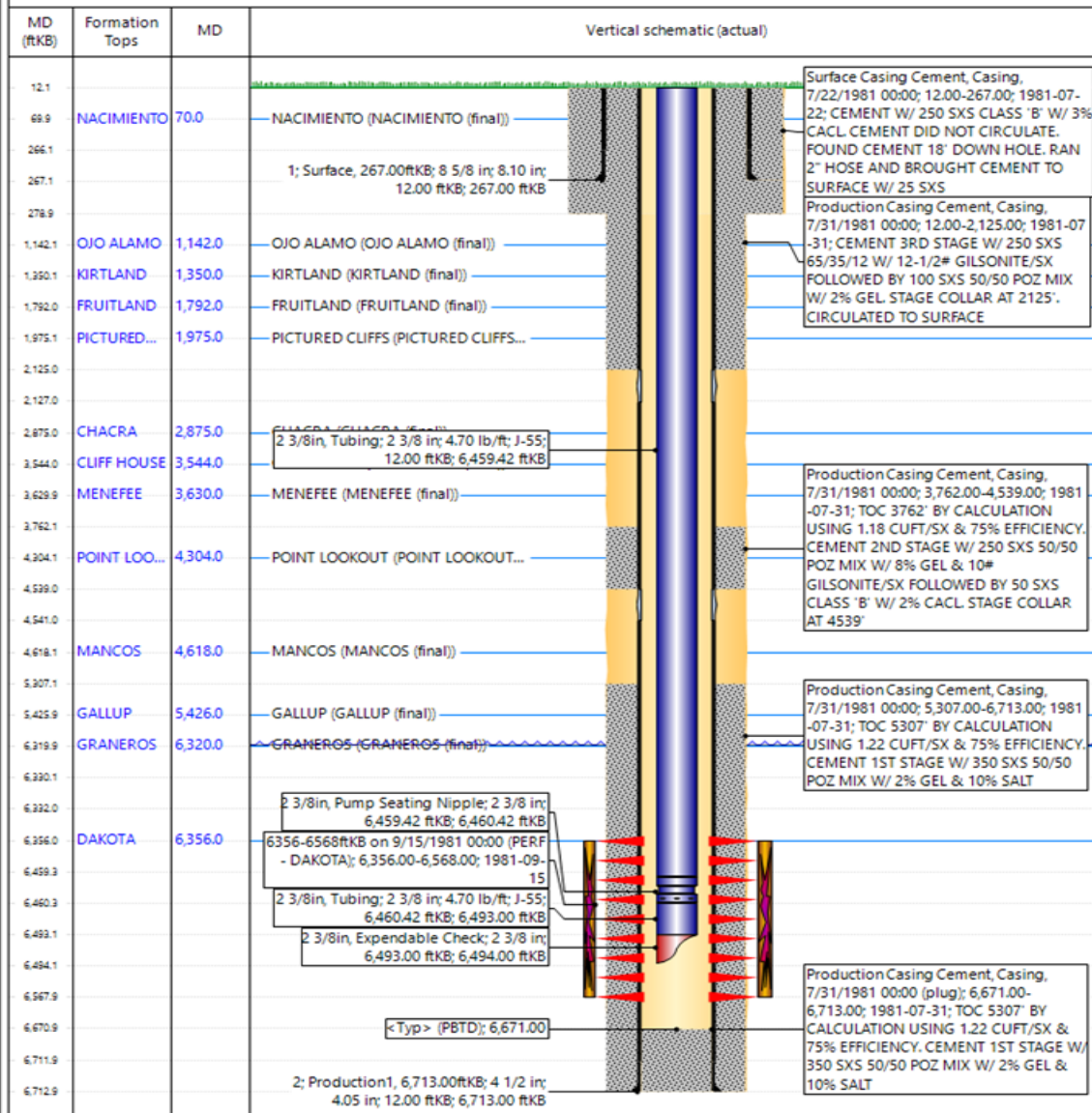

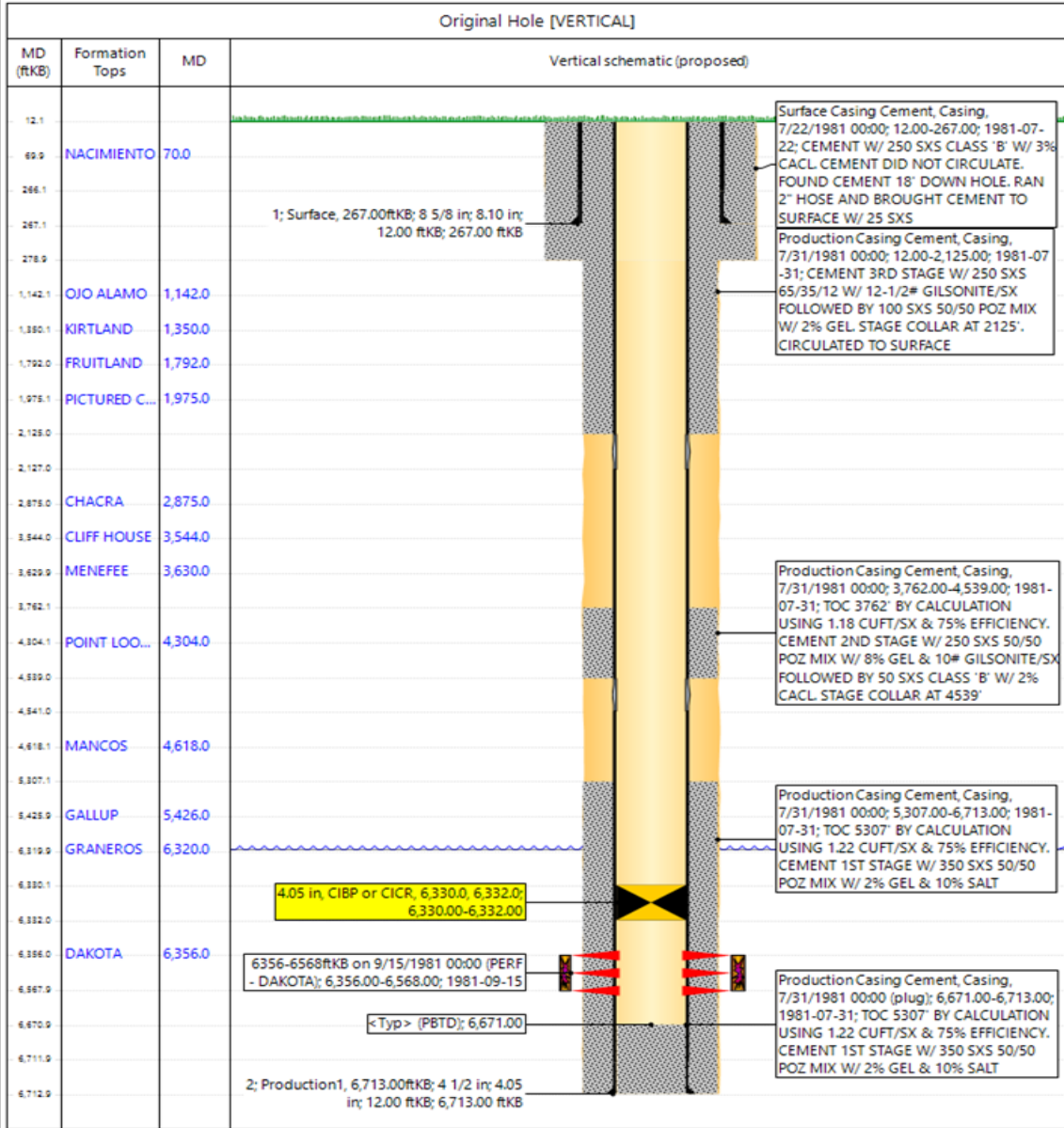
NEWSOM B 9E - PROPOSED WELLBORE SCHEMATIC

2. Also, after work is completed, send in a Sundry Notice – Notice of Intent requesting temporary abandonment status. Note approval is based on the discretion of this agency. This request must be submitted within 30 days after work is completed.

Include in the Notice of Intent the following:

- a. Proposed exact expiration date (month, day, year). Cannot be later than 12-months from date of submission. The date can also be when the current TA approval will expire.
  - b. Confirmation of other production on lease, or agreement.
  - c. Plans for the well.
3. This agency reserves the right to modify or rescind approval. A plug or produce order may still be issued at the discretion of the authorized officer.
  4. The lease is currently held by production from other wells. Should production from the lease cease, the BLM may require this well be returned to production or P&A, regardless of the amount of time the TA status is still approved for.
