
JOB PROCEDURES

Please notify BLM (505-497-0019 - Kenneth Rennick) and NMOCD (505-320-0243 - Monica Kuehling) at least 24 hrs before the rig arrives to prep the well. Please log all phone calls in daily rig reports. Comply with all NMOCD, BLM, and HEC safety and environmental regulations.

- 1. Notify BLM / NMOCD at least 48 hours prior to conducting the MIT.
- 2. Record current wellhead pressures, ND exisiting piping on casing valve
- 3. RU pump truck, pressure test surface equipment and wellhead to 1000 psi
- 4. Load well and pressure test CIBP at 9,730' to 580 psi, hold for 30 minutes and chart on a 2 hour chart. Monitor tbg and surface csg pressures
- 5. Bleed off pressure, break out surface piping and RD pump truck. NU exisitng piping.

CONDITIONS OF APPROVAL

The Code of Federal Regulation, 43CFR3162.3-4(a) requires that any well that is not capable of producing in paying quantities must be promptly plugged and abandoned, after approval from BLM. Before expiration of this NOI, Hilcorp Energy Company must exercise one of the following options:

- Return the well to production, in paying quantities. Paying quantities being defined as: production of oil or gas of sufficient value to exceed direct operating costs and the costs of lease rentals, or minimum royalty, on a sustained basis.
- If you believe the well capable of producing in paying quantities but wish to leave the well as TA, you must submit supporting documentation and a time frame for returning the well to production.
- Submit a Sundry Notice of Intent to Abandon (NOIA) with plugging procedures for the well.

All previous Conditions of Approval remain in effect.
