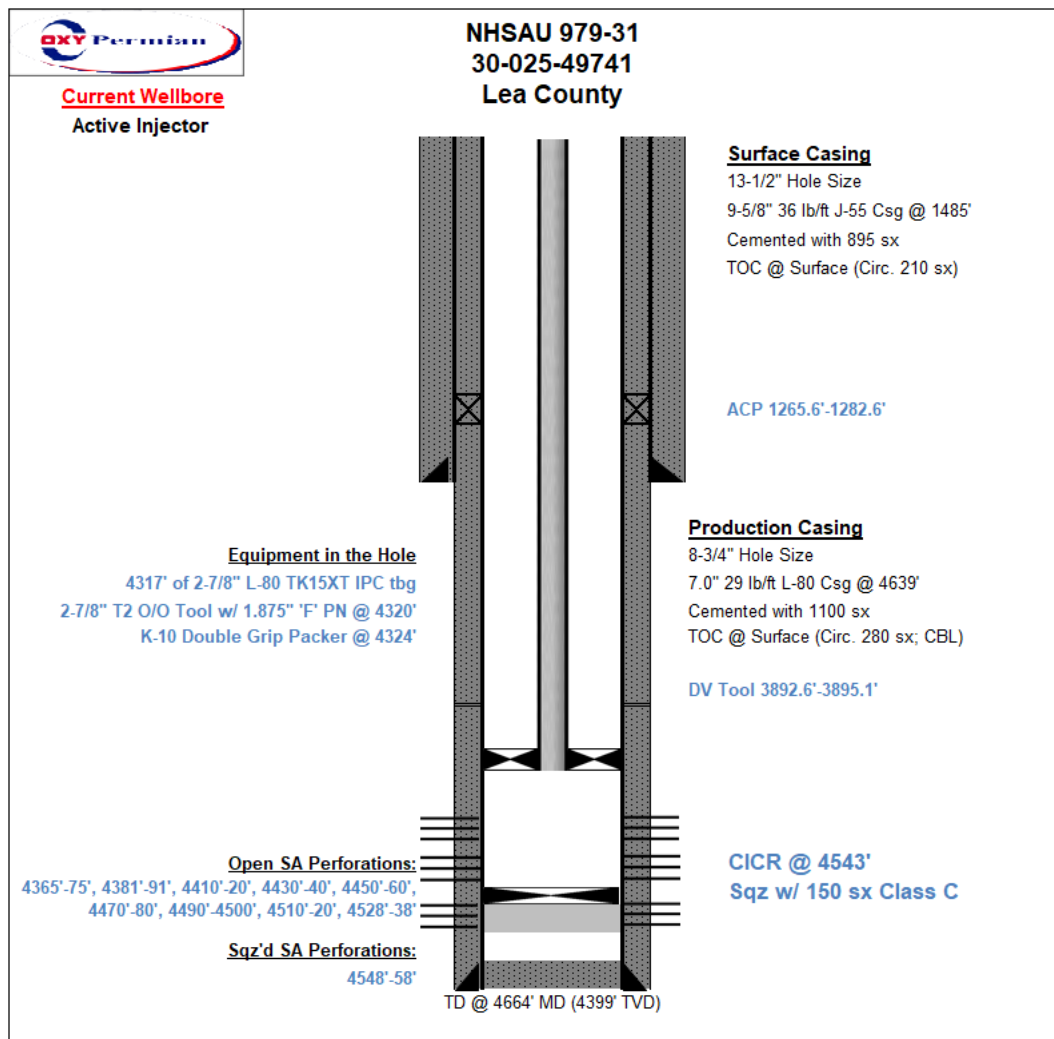

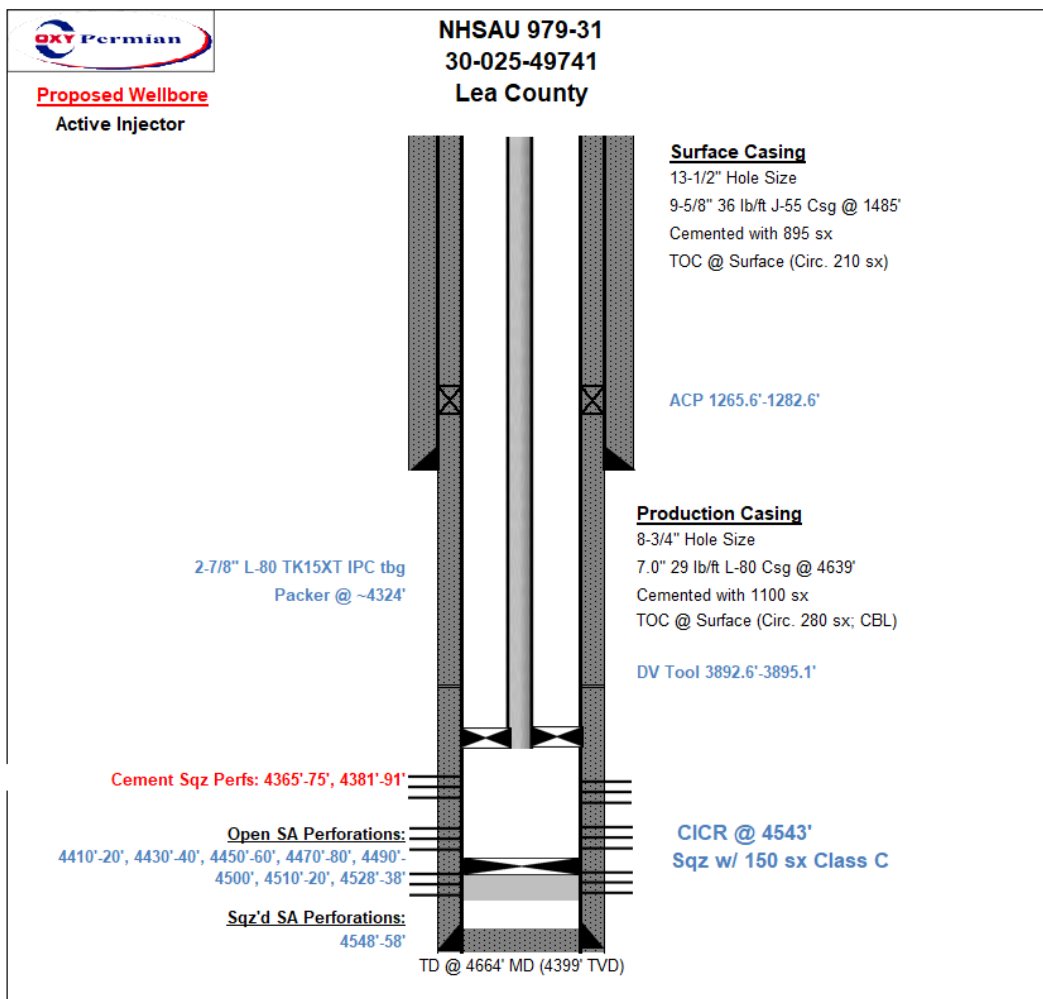

2. Sqz all perfs f/ 4365'-4538' w/ ~500 sx Class C cmt.
3. DO cmt to PBTD 4543'. Pressure test squeeze.
4. Reperf & acidize f/ 4410' to 4538' gross interval.
5. Install injection equipment.
6. Return well to injection
