7/17/2023: Test BOPS. Drill 11 inch intermediate hole to 5667 ft.

7/19/2023: Run 8.625 inch 32 lb J-55 intermediate casing to 5647 ft. Pump 30 bbls water spacer, followed by 840 sks of 11.2 ppg lead cmt, 290 sks of 14.8 ppg tail cmt. Drop plug and displace with 341 bbls fresh water. 118 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

9/18/2023: Drill 7.875 inch production hole to 10067 ft then switch to 6.75 in hole to 20877 ft.

9/28/2023: Run 5.5 inch 20 lb P-110 production casing to 20862 ft MD. Pump 40 bbls gel spacer, then 442 sks of 10.5 ppg lead cmt and 1050 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water then 442 bbls fresh water. 102 bbls returned to surface. Est TOC at 0 ft.
