Pump and balance 175 sx of 17.2 ppg (0.97 ft3/sx) cement at 12,808'. TOOH to surface and test BOPE on 9/14. TIH on 9/15/23 and tag abandonment plug at 12,393' showing TOC ~365' above casing shoe. TOOH on 9/15 to set whipstock.

I'm currently on the Ragin Cajun 12-13 Fed Com 5H pilot hole (30-025-48508). The original top of Strawn was estimated to be at 14,500', but our top of Strawn actually came in at 14,314'. Due to this shift in the top, we plan to move our Strawn plug up to put the base at 14,500' and the top at 14,100'. Will this be acceptable for the BLM?
