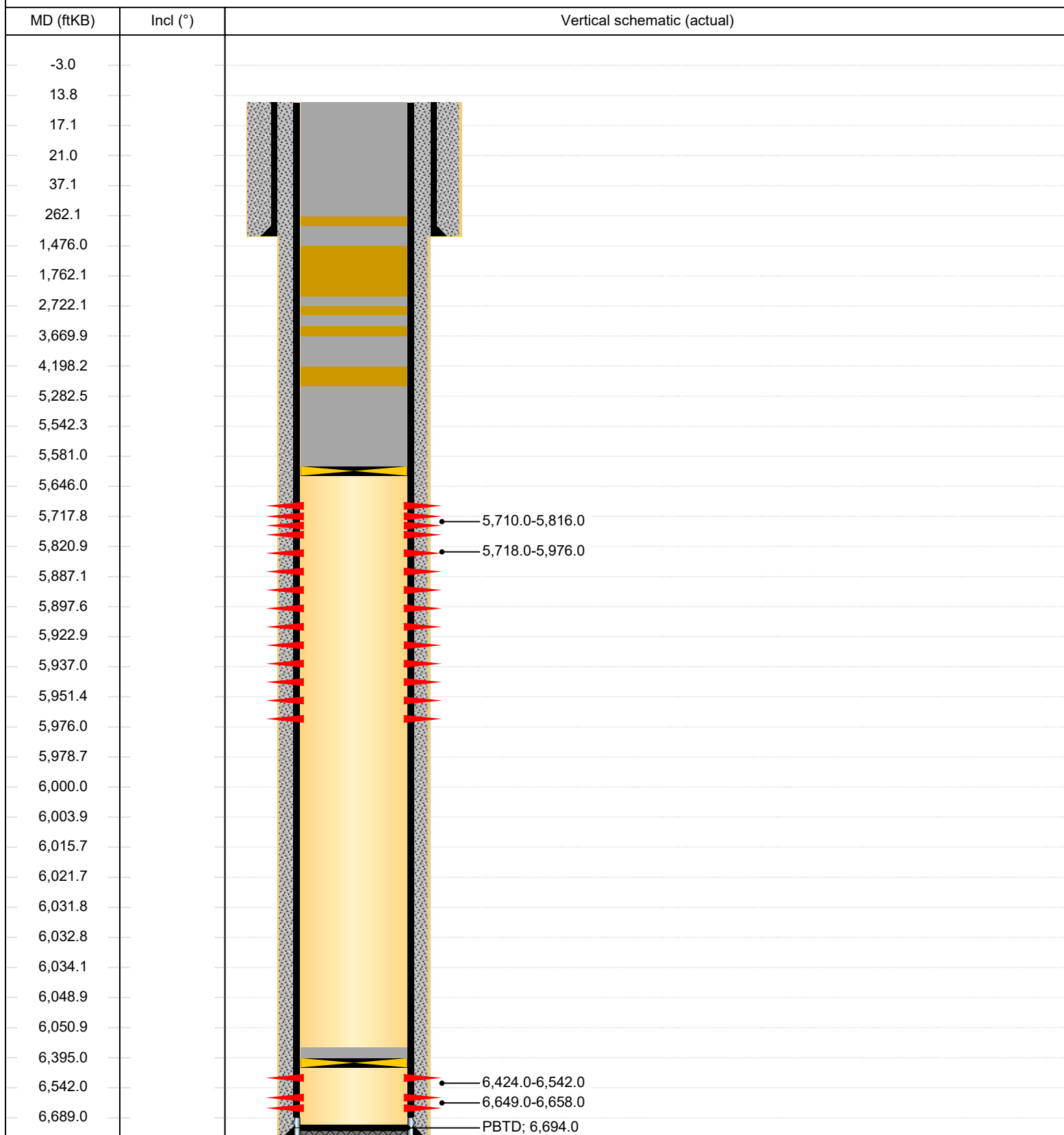


## Schematic - Current
