Actual Procedure: Well spud on 12/4/2024 at 23:15 12/4/2024: Drill 14.75 inch surface hole to 370ft. 12/5/2024: Run 11.75 inch 42.0 lb J-55 surface casing to 353 ft. Pump 10 bbl sodium silicate, 20 bbl water spacer, followed 355 sks of 14.8 ppg tail cmt. Drop plug and displace with 37 bbls freshwater. No cmt returns. Pressure test casing to 1500 PSI for 30 minutes, good test. Perform top out job, pumping 55 bbls of 14.8 ppg cmt, no returns. Repeat process for second top out job, no returns. Pump 85 bbls of 14.8 ppg cmt, no returns for third top out job. Pump 30 bbls of 14.2 ppg cmt. 10 bbls of cmt returned to surface. Pump 2 bbls freshwater, followed by 30 bbls of 14.2 ppg cement (60 sks – 2.83 ft/sack). 10 bbls of cement to surface (20 sks).
