ALLISON 24A - CURRENT WELLBORE SCHEMATIC

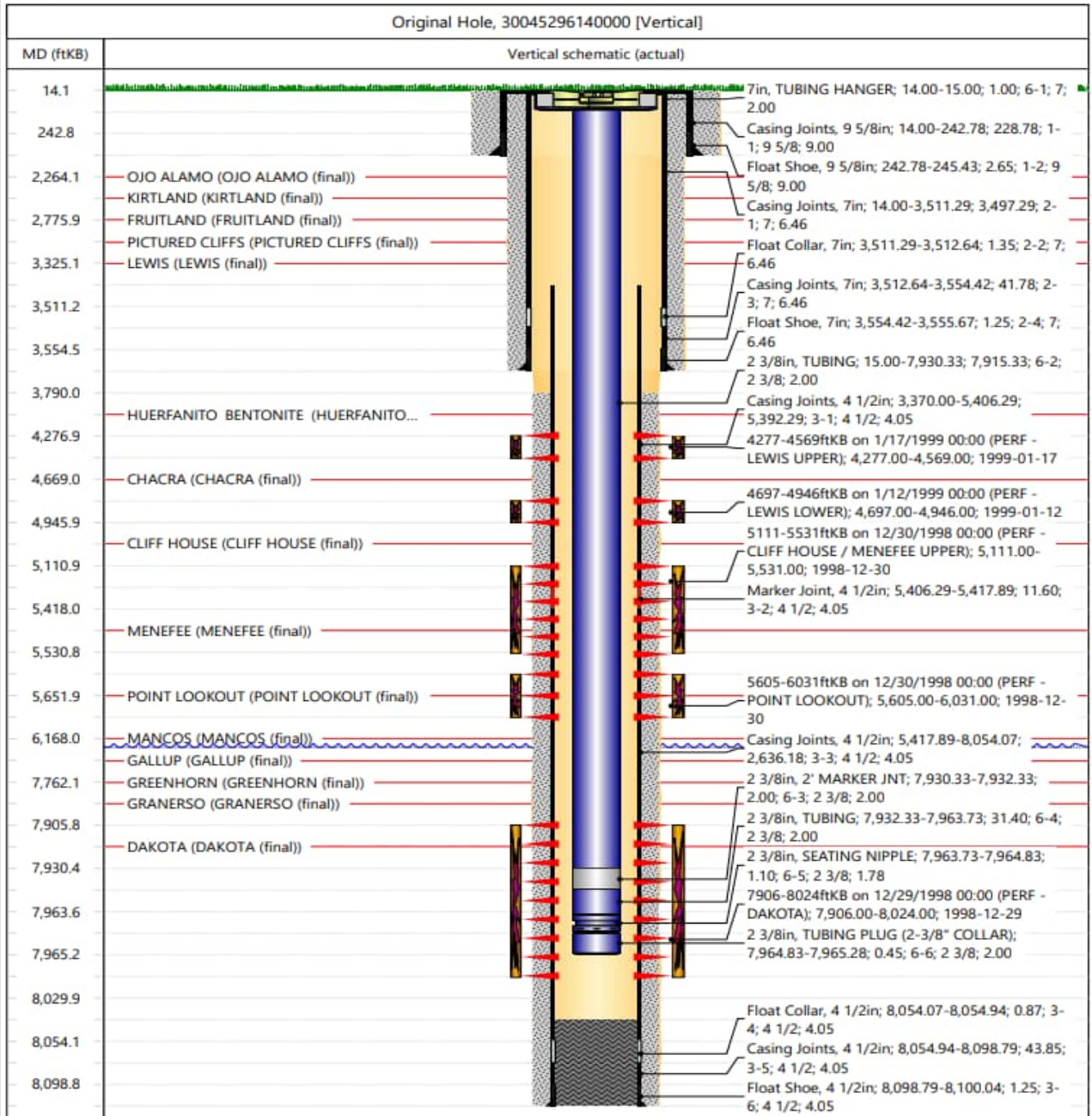

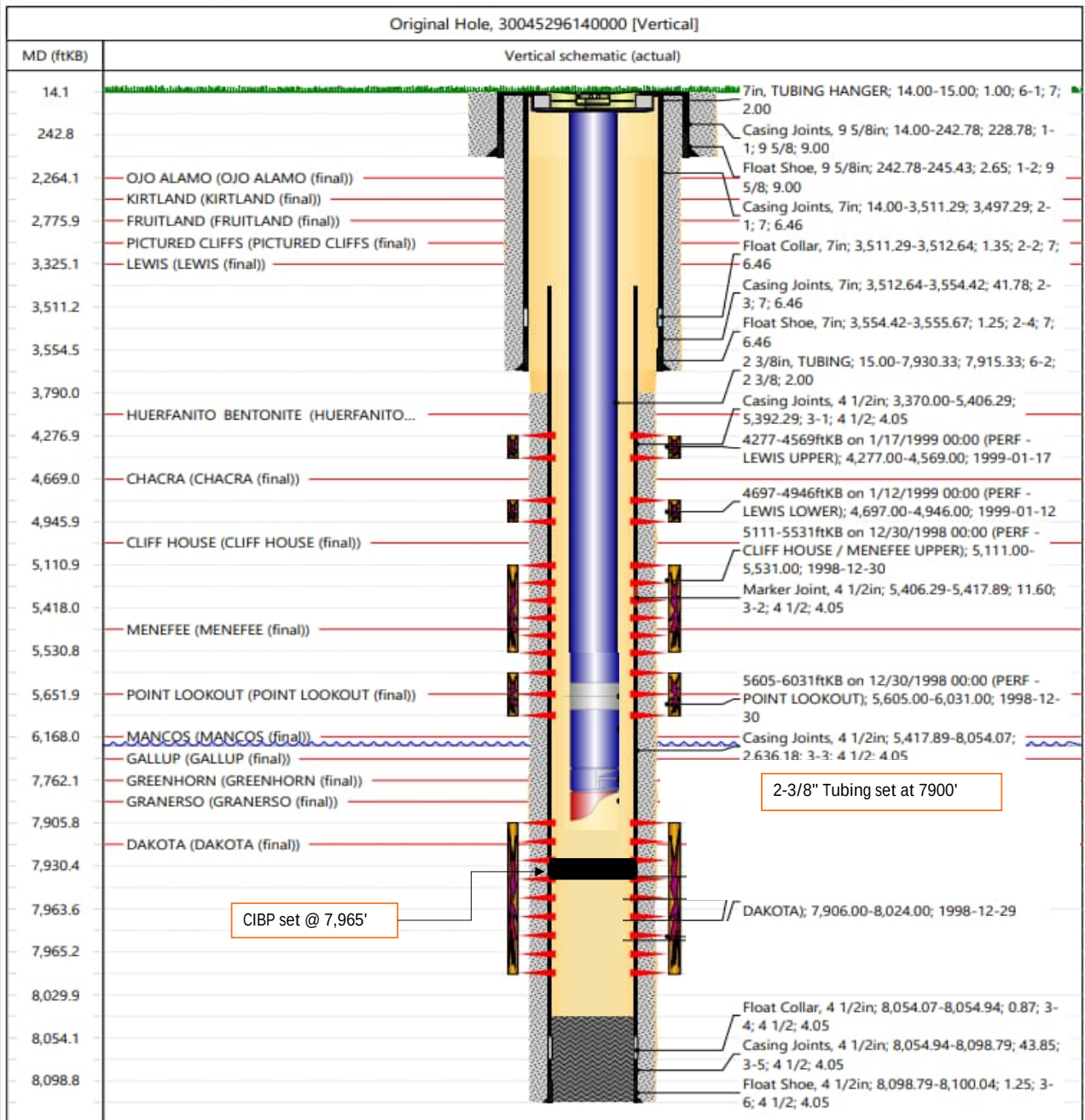
ALLISON 24A - PROPOSED WELLBORE SCHEMATIC
