Procedure Description: Try to establish an injection rate into the annulus. If successful do a bradenhead squeeze. If unable to inject at minimum rate of 2.5 bpm using a MAWHTP of 3,000 psi. Set RBP @ 8,000' MD; Perforate squeeze holes @ 4,880' MD; Squeeze under a packer w/ Class C cement. Drill out, Test, Retrieve RBP, return to production.


