Horizontal Schematic Details

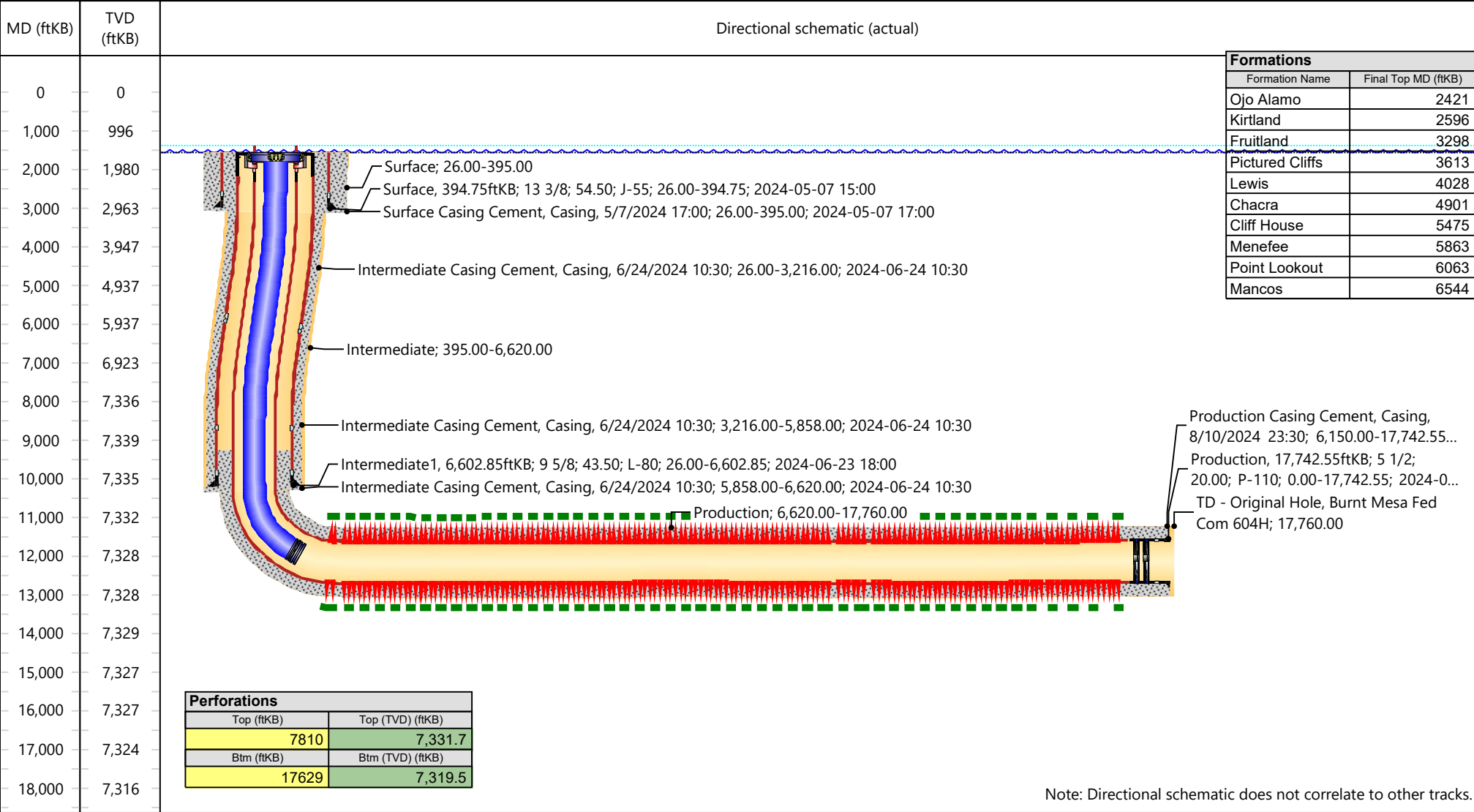
