Background/Purpose

Set RBP to isolate production zones and safeguard well integrity during nearby offset fracturing treatments.

Procedure:

Prior to rig move ensure anchors and road are in shape for rig and associated equipment

- 1. MIRU Service Unit. Hold safety meeting with all personnel on location and explain job procedure and possible hazards.
- 2. ND WH, NU BOP, RU rig floor and 2 3/8" handling tools.
- 3. POOH 2 3/8" production string including set at ~5661'.
- 4. TIH with 4.5" casing scraper to approx 5280'.
- 5. TIH with Retrievable Bridge Plug (RBP) and running tools to approx 5274'.
- 6. Set RBP @ approx 5274' using third party procedure. (~150' above top perf)
- 7. Fill hole with water, POOH.
- 8. RDMO
