Procedure Description: Matador Production Company respectfully requests that the Bureau of Land Management (“BLM”) approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC received these APDs as part of its acquisition of Ameredev in 2024 and there are eleven horizontal wells currently producing on this unit. MPC plans to drill six wells the adjacent property (MPC’s Dogwood Project) in Q1 2026 and believes it would be best practice to monitor the production from these future wells to inform how MPC should continue its development on the Nandina project. As a result, a 24-month extension is requested to prudently develop the remainder of the Nandina project and reduce waste.
