Procedure Description: BLM Bond NMB001079 Surety Bond No.: RLB0015172 Matador Production Company respectfully requests that the Bureau of Land Management (“BLM”) approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC received ten permits in November 2023 and proceeded to spud seven horizontal wells in January 2024. MPC is scheduled to spud the remaining three Cathy Bryce wells in Q4 2026. As a result, a 24-month extension is requested to prudently develop the remainder of the Cathy Bryce project and reduce waste.
