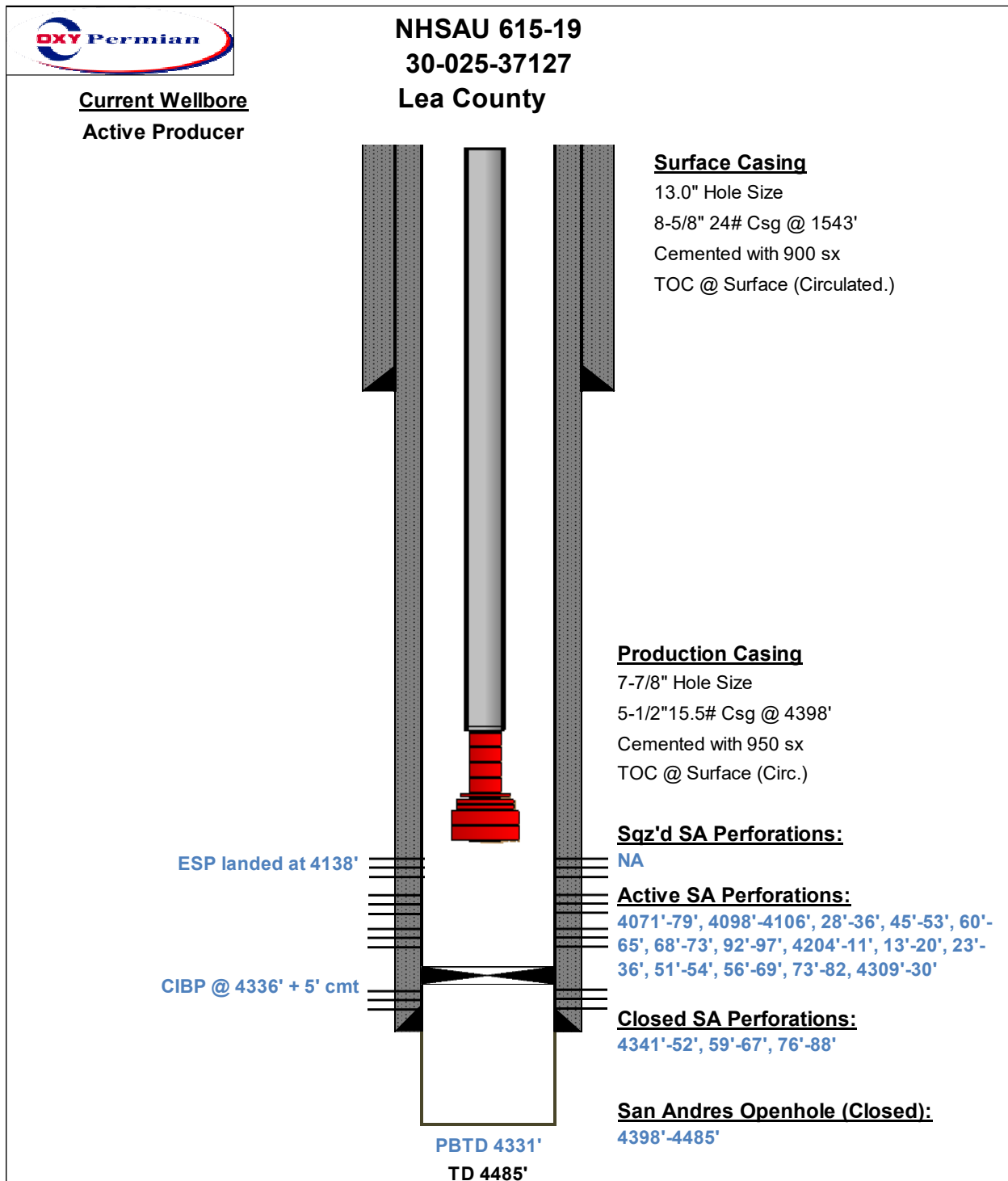

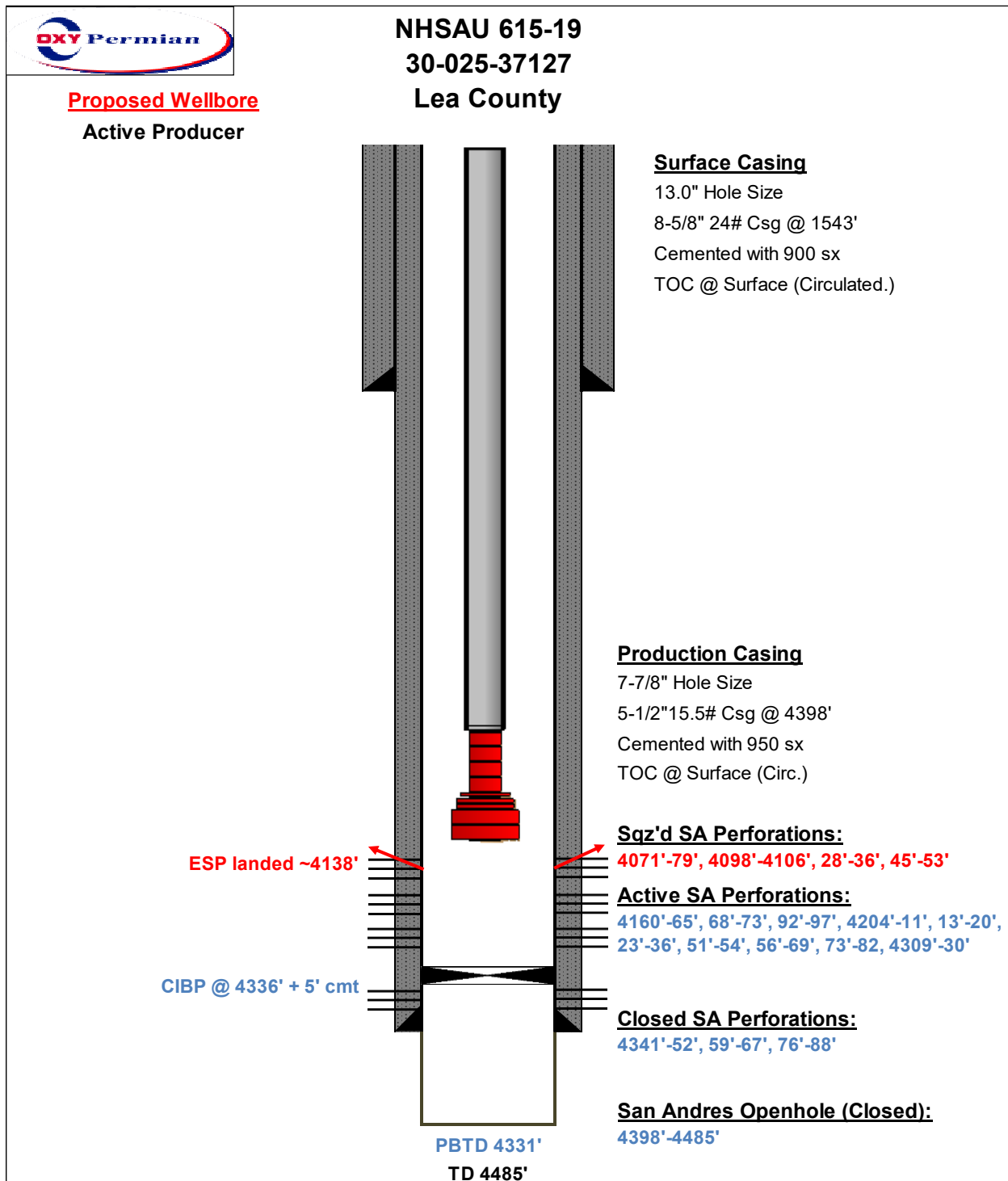
Job Plan:
