Pump 30 bbls spacer, followed by 240 sks of 13.5 ppg lead cmt, 120 sks of 14.8 ppg tail cmt. Drop plug and displace with 90 bbls of freshwater. 21 bbls of cmt to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
