The plan is to rig up a pulling unit with hydraulic BOP and to pick up the tubing string, leaving the existing packer in place. The full injection string will be pulled and inspected, as will tree components. Any damaged equipment will be replaced with new or refurb'd equipment. The Injection string will be comprised of the same 4", 11.0#, L80 flush joint tubing with either an IPC coating or GRE lining from surface to the top of the packer assembly at 8,749'. The packer will remain in the well, with COE @ 8,753'. A new MIT and BHT will be called out and performed after the workover to ensure wellbore integrity.

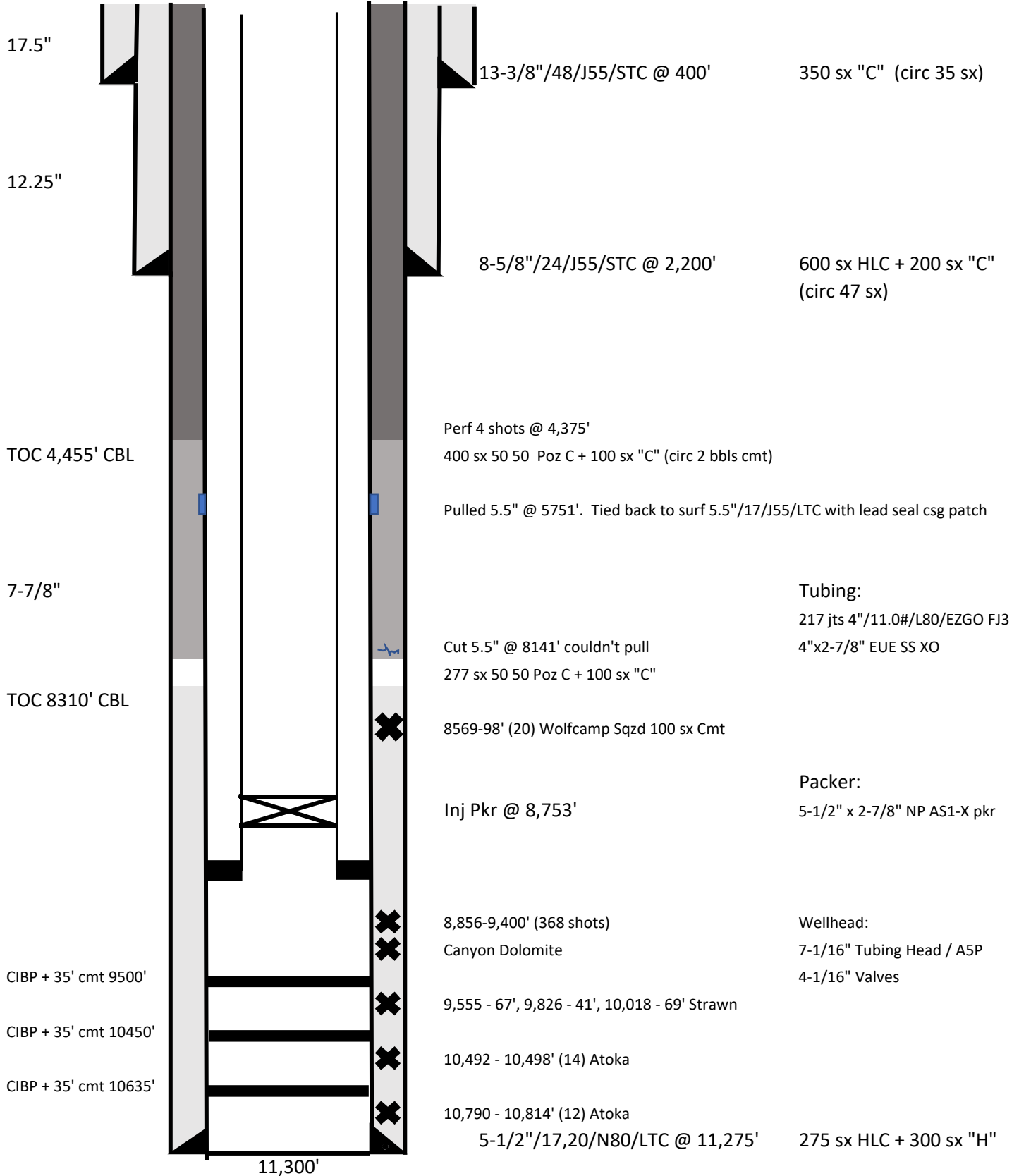

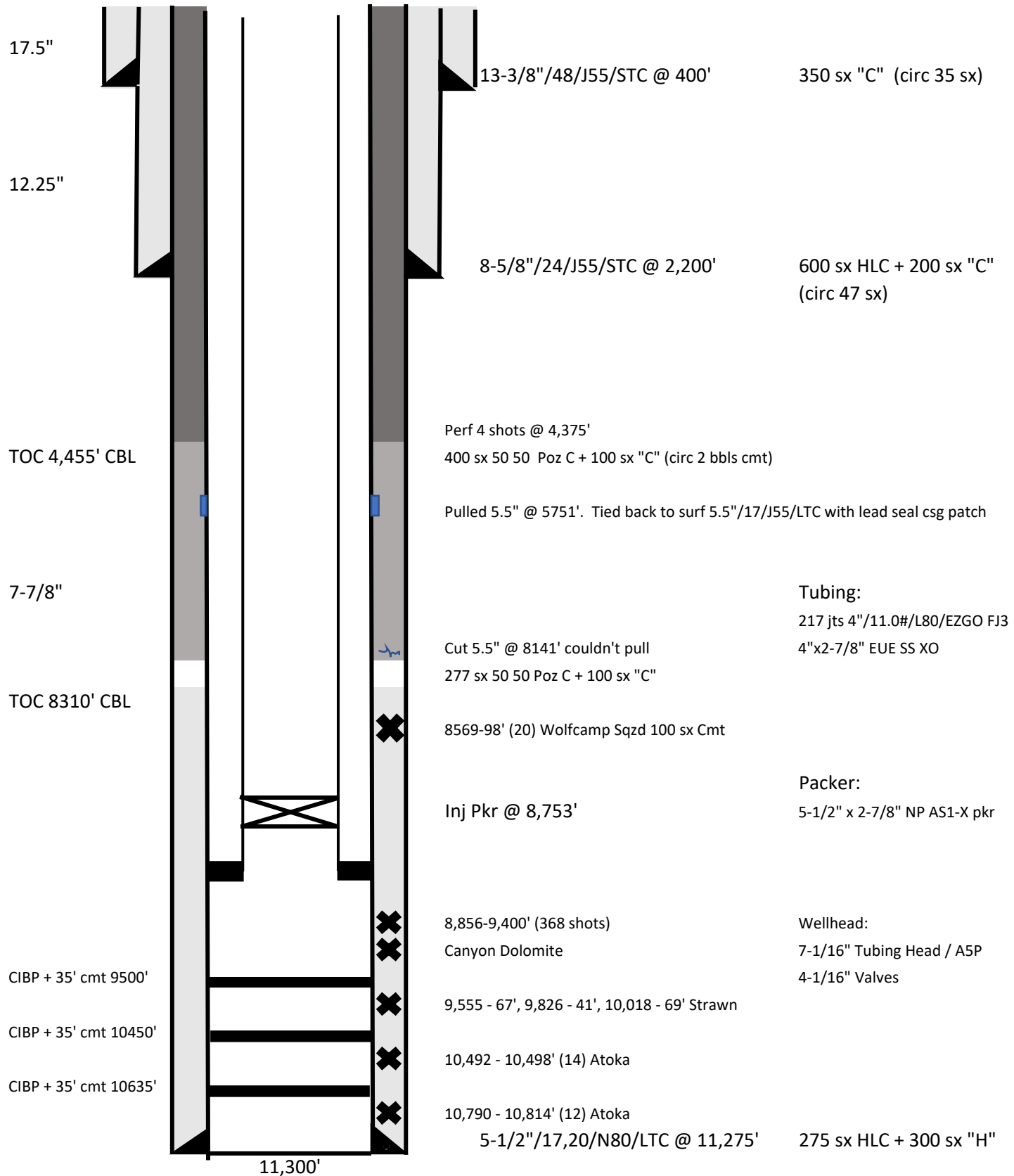
