Thanks for taking my call concerning the 10-3/4" 2 stage cement job on Pimento 115H (API: 30-025-52831).

As discussed we are going to wait on the 2nd stage tail to gain compressive strength of 500 psi (4:43hrs). From there, we will top out with class C neat cement then conduct. After pumping the top job, we will execute a temperature survey at 6-8 hours to locate top of cement.
