**Actual Procedure:** Marathon Oil Permian LLC is submitting drilling operations sundry to add additional cement detail. 12/16/2022 - MIRU. 12/18/2022 - Notify BLM of Intent to Spud, run casing and cement. Spud well and drill 17-1/2" surface hole to 572'. 12/19/2022 - Run 13-3/8", 54.5#, J55, BTC casing to 561'. Cement casing with 20 bbls spacer and 725 sks, 1.33 yield, 14.8 PPG, Class C of tail cement with 94 bbls (396SX) of cement circulated back to surface. Pressure test surface casing to 1500 psi for 30 min., held, good test. Release rig and skid off. 1/4/2023 - Skid rig back up. Retest surface casing to 1500 psi for 30 min, held, good test. Test BOP. 1/5/2023 - Drill out float equipment, shoe track, and 10' of new formation to 582'. Drill 12-1/4" intermediate hole to 9037'. 1/11/2023 - Notify BLM of intent to run and cement intermediate casing. Run 9-5/8", 40#, P110HC, BTC casing to 9027'. 1/12/2023 - Cement intermediate casing with 25 bbls spacer, 991 sks, Class C, 1.33YLD, 14.8 PPG of lead cement, and 1020 sks, 1.33 yield, 14.8PPG, Class C of tail cement with 390 bbls (1646SX) of lead cement ciruclated back to surface. Pressure test intermediate casing to 4000 psi for 30 min, held, good test. 1/13/2023 - Drill out shoe track and 10' of new formation to 9047'. Start drilling 8-3/4" vertical to 9112'. Drill 8-3/4" curve to 10064'. 1/15/2023 - Drill 8-3/4" lateral to 19765' (TD). 1/18/2023 - Reach TD at 19765'. Notify BLM of intent to run and cement production casing. 1/20/2023 - Run 5-1/2", 23#, P110CY, TLW casing to 19757'. Cement casing with 50 bbls of spacer, 1576 sks, 1.32 yield, 11.5PPG, Class H of lead cement, 3395 sks, 1.04 yield, Class H of tail cement, with 90 bbls (379 SX) of lead cement circulated to surface. 1/20/2023 - Release Rig and move out. 3/1/23 Pressure test Production casing 13000psi, 30 mins. Good test
