

Dugan Production plugged and abandoned the Martinez Begay Com #2 from **12-01-2025 to 12-03-2025** per the following procedure:

- MI&RU Aztec Well Service Rig 481. Spot in and RU cement equipment.
- Check pressures: Tubing 0 psi, Casing 5 psi, BH 0 psi.
- Pull and LD production rods and tubing.
- PU & tally 2-3/8" work string. Run 5½" string mill to scrape casing to 1050'.
- RIH & set 5½" cement retainer at 1010'. Fruitland perforations @ 1060' – 1080'.
- Load and circulate hole clean with 30 bbls of water.
- **Pressure test casing to 700 psi for 30 minutes. Good test.**
- Run CBL from 1010' to surface. Sent copy of CBL to NMOCD. Copy of communications attached.
- Attempt to establish injection rate below CICR, pressured up to 1200 psi. No injection rate.
- **Plug I, Pictured Cliffs-Fruitland-Kirtland-Ojo Alamo-Surface:** Spot Plug I inside 5½" casing above cement retainer at 1010' to 150' w/100 sks (115 cu ft) Class G neat cement to cover the Pictured Cliffs, Fruitland, Kirtland, Ojo Alamo tops. Displace w/.5 bbls of water. **Plug I, Inside 5½" casing, cement retainer at 1010', 100 sks, 115 cu ft, Pictured Cliffs-Fruitland-Kirtland-Ojo Alamo, 150'-1010'.**
- **Plug II, Surface Casing Shoe-Surface:** RU Wireline. RIH and shoot squeeze holes at 100', established good circulation to surface through BH to pit. RIH w/tubing open ended to 157'. Swap to cement. Spot Plug II inside/outside 5½" casing from 157' to surface w/48 sks (55.2 cu ft) Class G neat cement to cover the surface casing shoe-surface. No displacement. WOC overnight. MI&RU welder, cut wellhead off. Tagged TOC at 0' inside, 0' annulus. **Plug II, Inside 5½" casing, perforations at 100', EOT at 157', 48 sks, 55.2 cu ft, surface casing shoe-surface, 0'-157'.**
- Fill cellar and install dry hole marker with 18 sks, 20.7 cu ft, Class G neat cement.
- RD Aztec Well Service Rig 481. Clean location, move.
- Clay Yazzie with BLM witnessed the job.
- Photos of P&A marker and GPS coordinates attached per NMOCD COA.
- **Well P&A'd on 12/03/2025.**
