**Procedure Description:** Matador Production Company respectfully requests that the Bureau of Land Management (“BLM”) approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC received these APD as part of its acquisition of Ameredev in 2024 and has submitted sundries to modify the wells to fit Matador’s technical specification. MPC spud 5 wells in the summer of 2025 and believes it would be best practice to monitor the production from these well to inform how MPC should continue its development of this project. APDs set to expire 2/20/2026. As a result, a 24-month extension is requested to prudently develop the remainder of the Juniper project and reduce waste.
