Enclosed is an approved copy of Communitization Agreement NM135756 involving 80 acres of Fee land, 40 acres of Federal land in lease NMNM121490, 40 acres of Federal land in lease NMNM84898 and 76.71 acres of Federal land in lease NMNM02965A, Lea County, New Mexico, which comprise a 236.71 acre well spacing unit.

The agreement communitizes all rights to all producible hydrocarbons from the Bone Spring and Wolfcamp formations beneath the E2E2 of sec. 28, and the NENE and Lot 1 of sec. 33, T. 26 S., R. 33 E., NMPM, and is effective 12/01/2015. 

- A. Approval of this agreement does not warrant or certify that the operator thereof and other holders of operating rights hold legal or equitable title to those rights in the subject leases which are committed hereto.
- B. Approve the attached Communitization Agreement covering the E2E2 of sec. 28, and the NENE and Lot 1 of sec. 33, T. 26 S., R. 33 E., NMPM, as to all producible hydrocarbons from the Bone Spring and Wolfcamp formations. 
