Enclosed, per BLM request is one corrected, approved copy of Communitization Agreement NMNM122596, involving 120 acres of Federal land in lease NM81953 (corrected from 159.88) and 39.92 acres of Federal land in lease NM0281482A in Eddy County, New Mexico, comprising a 159.92 (corrected from 199.80) acre well spacing unit.


The agreement communitizes all rights as to the gas and associated liquid hydrocarbons producible from the Delaware formation in Lot 3 (Lot 2 removed), SENW and E2SW of Section 5, T. 23 S., R. 31 E., NMPM, and is effective February 15, 2008. The Exhibit A plat has been corrected to reflect the corrections as well as Exhibit B, description of the lands committed. The Recapitulation Page has been changed to 159.92 acres (corrected from 199.80) and percentage of interest has been changed to 75% for Tract 1 and 20% for Tract 2 (corrected from 80% and 20% respectively). Approval of this agreement does not warrant or certify that the operator, thereof, and other working interest owners hold legal or equitable title to the leases which are committed hereto.

Copies of this corrected letter are being distributed to the appropriated Federal agencies. You are requested to furnish all interested parties with the appropriated evidence of the corrections.
