The Consolidated Delaware Formation Participating Area "DE" is hereby approved effective as of July 1, 2011, pursuant to Section 11 of the Poker Lake Unit Agreement, Eddy County, New Mexico. This participating area has been designated NMNM71016AE.

The Consolidated Delaware Participating Area "DE" consolidates the existing Delaware Formation Participating Area "D" and the Delaware Formation Participating Area "E".

The application establishes a Consolidated Delaware Formation Participating Area "DE" of 1,080.00 acres and is based upon the completion of unit well 293H, located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  (SHL) of Section 21, T.24S., R.30E., unit tract No. 43, Lease No. NMLC068431 and in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  (BHL) of Section 22, T.24S., R.30E., unit tract No. 42, Lease No. NMLC068430 (Lateral 1), and in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  (SHL) of Section 21, T.24S., R.30E., unit tract No. 43, Lease No. NMLC068431 and in the NW $\frac{1}{4}$ NW $\frac{1}{4}$  (BHL) of Section 16, T.24S., R.30E., unit tract No. 63, state lease (Lateral 2) with an initial potential of 967 BOPD and 798 MCFPD on July 3, 2011, from the Delaware Formation.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" are returned herewith. Please advise all interested parties of the approval of the Consolidated Delaware Formation Participating Area "DE" effective as of July 1, 2011.

Any production royalties that are due must be reported and paid within 30 days of the Bureau of

Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (30 CFR 218.54). 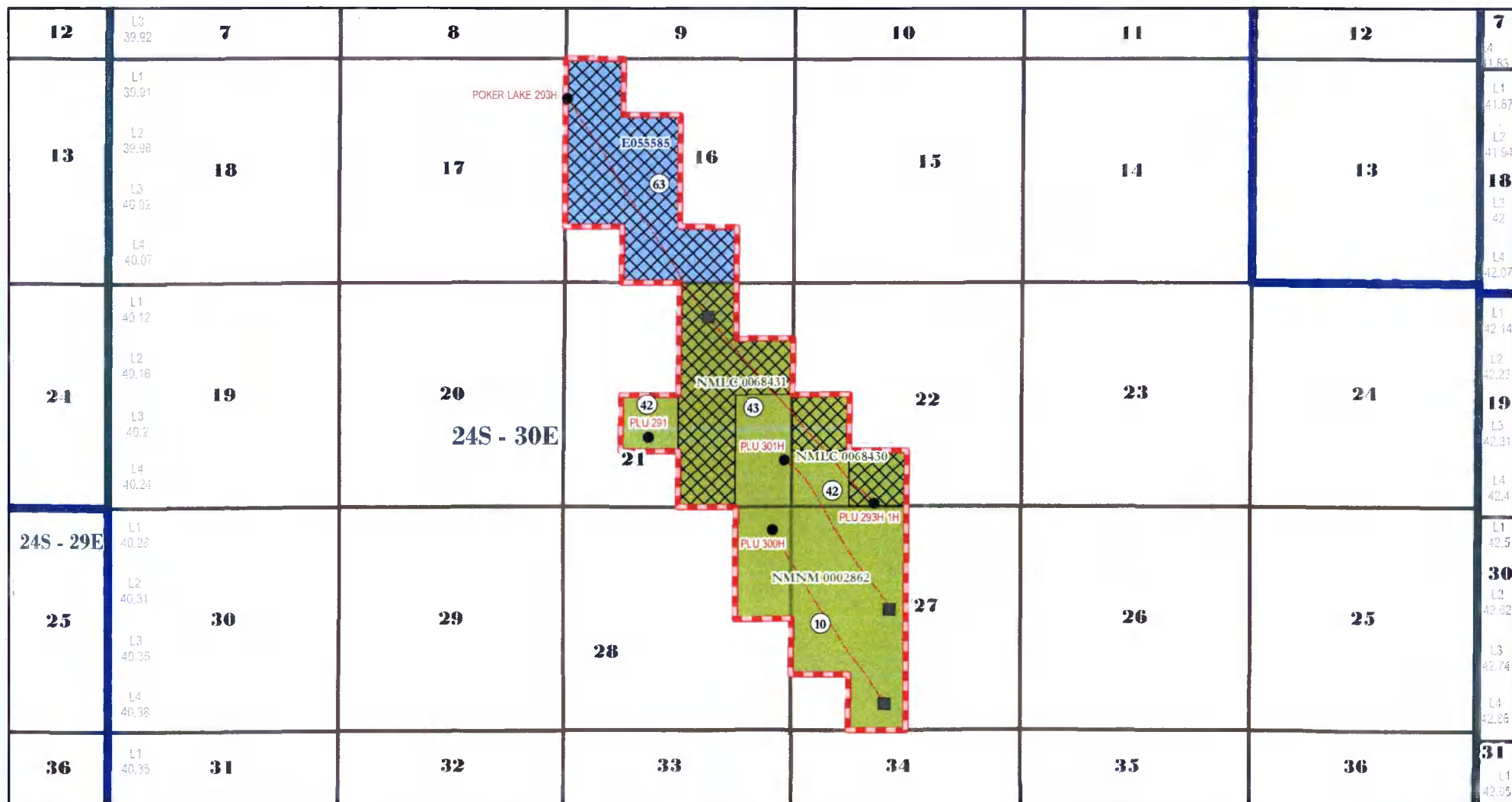
