05/10/06 Spud @ 12:30 p.m. Drill 11" surface hole to 333'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 323'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 9 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

05/09/06 Drill 7 7/8" hole from 333' - 2,785'. Reached TD 2,785' at 3:30 a.m. MIRU Patterson and log well. Logger's TD at 2,739'. Run 82 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,659'. HES mixed and pumped 365 sks Midcon II cement. Circulated 29 bbls cement to surface.
