- 07/17/03 Spud in @ 9:30 p.m. Drill 11" surface hole to 355'. Ran 8 jts of 8 5/8", J-55, 24 ppf ST&C casing to 345'. Halliburton mixed and pumped 105 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 80 psi with 6% salt, .3% gilsonite, .3% versaset, and 25# flocele per sack. Circulated 10 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.
- 07/18/03 Drill 7 7/8" hole f/ 355' - 2510'. Reached TD at 2510'. MIRU Schlumberger & log well. Ran 12 jts of 5 1/2", J-55, and 47 jts of 5 1/2", M-50, 15.5 ppf LT & C casing to 2476'. Halliburton mixed and pump 40 bbls gel pre flush at 4 bpm at 80 psi, 385 sks Midcon II, 13.0 ppg, yield 2.04, .3% versaset, 5#/sx gilsonite, 2#/sk granulite, 6% salt and .1% Super CBL.
- 07/19/03 Plug down at 7:45 a.m. No returns during displacement. Well shut in.
