05/01/07 Drill 7 7/8" hole from 333' - 2605'. Reached TD at 2605' at 4:15 a.m. MIRU Superior and log well. Logger's TD 2601'. Run 55 jts 5 1/2", 15.5 ppf, J-55, and 10 jts 17 ppf, J-55 LT& C casing at 2526'. HES mixed and pumped 370 sks Midcon II cement. Circulated 30 bbls of cement to surface.
