Killed tbg w/ PW, RU stripper head and swivel, lowered and tagged frac valve, found tbg plugged and could not pump down, dry drilled on plug w/ 60 RPM and 3 points, made 4" and pushed plug to 2925', 39' below bottom perf. Killed well, TOH laying down work string, 2 7/8" drill collars, mill, note tbg pulled wet. found 1 drill collar plugged and mill plugged with composite material. RDMO Sundown rig # 201, cleaned location, turned over to area.

WOP Rugged up on well after frac, cleaned sand, drill and or push Weatherford Frac valve to 2923', 39' below bottom perf, returned to production.
