02/07/04 Spud in @ 7:30 p.m. Drill 11" surface hole to 370'. Ran 8 jts of 8 5/8", J-55, 24 ppf ST&C casing to 364'. Halliburton mixed and pumped 100 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 110 psi with 6% salt, .3% gilsonite, .3% versaset, and 25# flocele per sack. Circulated 4 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.

02/08/04 Drill 7 7/8" hole f/ 370' - 2875'. Reached TD at 2875'. MIRU Schlumberger & log well. Logger TD at 2847'.

02/09/04 Ran 72 jts of 5 1/2", 17#, J-55 LT & C casing to 2823'. Halliburton mixed and pump 70 bbls gel pre flush at 4 bpm at 30 psi, 406 sks Midcon II, 13.0 ppg, yield 2.04, .3% versaset, 5#/sx gilsonite, 2#/sk granulite, 6% salt and .1% Super CBL. Circulated 26 bbls cement to pit. Well shut in.
