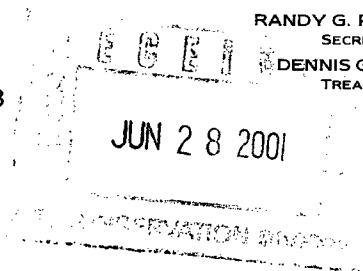

Dear Mrs. Wrontenberg:

Yates Petroleum Corporation respectfully requests that the captioned order be amended to include the Atoka and Morrow formations.

Yates re-entered this well in September of 2000, deepened it to a depth of 13,300 feet, tested the Mississippian formation for gas and was un-successful. We then came up the wellbore and established commercial gas production in the Morrow formation with perfs between 12,678 - 12,692'.

Yates also believes that there is future "behind the pipe" Atoka gas production in the wellbore and would therefore like to include the Atoka formation.

The Hobbs OCD office has advised Yates that this administrative order will have to be amended before we can produce the Arreguy AVM #1 in the Atoka/Morrow formation.

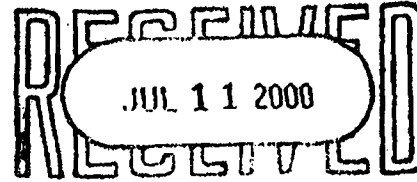

Administrative Order NSL-4479

Dear Mr. Bullock:

Reference is made to the following: (i) your application dated June 27, 2000; and (ii) the records of the New Mexico Oil Conservation Division ("Division") in Santa Fe: all concerning Yates Petroleum Corporation's ("Yates") request for an unorthodox wildcat Mississippian gas well location for the plugged and abandoned Arreguy "25" Well No. 1 (API No. 30-025-29998), to be redesignated the Arreguy "AVM" Well No. 1, located 810 feet from the North line and 510 feet from the East line (Unit A) of Section 25, Township 15 South, Range 34 East, NMPM, Lea County, New Mexico.

The Arreguy "25" Well No. 1 was originally drilled by Sun Exploration & Production Company to a total depth of 12,050 feet and completed in the Townsend-Permo Upper Pennsylvanian Pool at a standard oil well location in September/October 1987. In January, 1987 this well was plugged and abandoned.

It is our understanding that Yates now intends to reenter this well and deepen it to an approximate depth of 13,300 feet in order to test the Mississippian formation for gas within a standard 320-acre lay-down gas spacing and proration unit comprising the N/2 of Section 25.

This application has been duly filed under the provisions of Division Rule 104.F, revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999.

By the authority granted me under the provisions of Division Rule 104.F (2), the above-described unorthodox Mississippian gas well location is hereby approved.
