This letter acknowledges the receipt of your administrative application dated September 20, 2001 for Mack Energy Corporation's proposed State "S-19" Well No. 19, to be drilled at a standard oil well location 2310 feet from the South line and 550 feet from the West line of irregular Section 19, Township 17 South, Range 29 East, NMPM, Eddy County, New Mexico, within a non-standard 27.40-acre oil spacing and proration unit for the Empire-Yeso Pool (96210) comprising Lot 3 (NW/4 SW/4 equivalent) of Section 19.
